

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Tennessee Sumner County: SS

On this 14th day of August A.D. 1832 personally appeared before the Justice of the Court of Pleas & Quarter sessions now sitting Deloney Malone a resident Citizen of Sumner County State of Tennessee aged Seventy-three years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June the 7th 1832. That he entered the Service as a volunteer mounted man in the summer of the year A.D. 1780 immediately after the defeat of General Gates at Camden South Carolina [Battle of Camden, August 15-16, 1780] under Capt. Joshua Coffee in the County of Granville State of North Carolina for the term of three months and furnished his own horse. Capt. Coffee's Company was attached to Col. Philip Taylor's Regiment of mounted volunteers -- that he rendezvoused at Hillsboro North Carolina and marched from there to Salisbury and was joined by Col. Davy's [sic, William Richardson Davie's] Regiment and afterward by General Davidson [William Lee Davidson] -- and from there we marched to Charlotte North Carolina which place was at that time [late September and early October 1780] in the possession of the British. That he continued to do duty mostly in North Carolina sometimes in the edge [of] South Carolina until his term of service expired when he returned to Hillsboro where he was discharged he believes his discharge was signed by Col. Taylor he has long since lost or destroyed it.

In the spring of the year 1781 he again entered the service as a volunteer for the term of three months under Capt. Peter Bennett in Granville County State of North Carolina he rendezvoused in Mecklenburg County State of Virginia on the Roanoke River and was attached to Col. William Guill's [?]¹ Regiment and was stationed on the River to catch and salt up fish for the use of public during his whole term of service when it expired he was honorably discharged which he has lost. That he was born in Granville County State of North Carolina in the year 1759 -- he had a record of his age it is lost or destroyed -- that he resided in Granville County North Carolina when he was called into service -- that he remained there some time the close of the Revolutionary War. He removed from there to Virginia -- from thence to Kentucky and from thence to Sumner County State of Tennessee where he now resides and has lived for the last 28 or 30 years that he has no written or documentary evidence of his service nor knows of none, But believes that the evidence of Capt. Grant Allen and John Baynes² both of whom served with him

in the Revolutionary war will be sufficient to satisfy the war department of his services --

He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the Pension Roll of the Agency of any State.



I do hereby certify that I was well acquainted with Deloney Malone (who has sworn and subscribed the foregoing declaration for a Pension) in Granville County State of North Carolina and do certify that he did to my own personal knowledge serve in the Revolutionary War as he has stated under Capt. Joshua Coffee and that I belonged to the same company with him. I have been acquainted with him ever since and believe him to be entitled to credit.
