Declaration in order to obtain the benefit of the act of Congress, passed June 7, 1832.

State of Tennessee} September Term 1832 of the Court of Pleas and QuarterHenry County}Sessions

On this day the fourth day of September 1832 personally appeared in open court before the Justices of the County Court of Henry County now sitting Lewis Atkins a resident of the County of Henry and State aforesaid aged seventy six years, who being duly sworn according to law, on his oath makes the following declaration in order to obtain the benefit of the Act of Congress, prepared June 7, 1832.

That he entered the service as a volunteer under Capt. John Dejarnett and in the Regt commanded by Col. Thomas Wade, as a private shortly before Gates' defeat at Campden [Camden] the precise time he can not reccollect [sic], he then lived in and entered the service in the County of Anson, and State of North Carolina. He never served with any of the continental line and can give no account of his officers. He was engaged the greater part of his service in skirmishes with the Tories and several engagements with them, one on Black Creek and also at Betty Bridge on Drowing [Drowning] Creek. These were in N. Carolina but he can't say what County. After these skirmishes his Col. Thomas Wade was elected to the Assembly and this Regiment was transferred to one Smith, who moved the regt near Wilmington, N. Carolina, then in the possession of the Brittish [sic] army. The Regt. he belonged to were mounted gunmen were stationed on the opposite side of the river from Wilmington, Gen. Rutherford who as he understood was the commander of the Americans was with the infantry on the side of the town. The Brittish [sic] had some troops quartered in a brick house about a mile and a half on this side of the Cape Fear, and his regiment had skirmish with them & killed & wounded about thirty & while they were there, they also broke up a Tory station at a mill in the nighbourhood [sic] & killed & took twenty five prisoners, that his regt. was in that nighbourhood [sic] when he heard of Cornwallis defeat. They remained there some four weeks, & were then marched back to the County of Anson & discharged, which was signed by Capt. Dejarnett, the last of November in that year. That in all he served about seventeen months, his discharge has been mislain as he never supposed it would be of any service. Edmund Hogan was with him the last campaign to Wilmington & can prove that tour, he has no documentary evidence to prove that service or his other tours, states that he was born in the year 1756 on the 10<sup>th</sup> of April as appears from the record his father kept & which he now has, was born in Prince Edward County State of Virginia. Since the revolutionary war he has resided a greater part of his time in the county of Stewart State of Tennessee, but now & for the last seven years has lived in the county of Henry & same State. I am well acquainted & have for a long time acquainted with Elias Bowden Rev. Lem Myrick and Hamblin Manly of the Cty of Henry & State of Tenn. He hereby relinquishes any claim to a pension or annuity except the present & declares that his name is not on the pension roll of the agency of any State.

The amended declaration of Lewis Atkins for the purpose of obtaining a pension under the Act of Congress, passed June 7<sup>th</sup> 1832.

That from his old age and loss of memory he cannot state precisely his exact term of service but according to the best of recollection he served not less than the periods and at the times and

manner as hereinafter stated. That shortly before Gates defeat, the time he cannot recollect, he entered the service under Capt John Dejarnett in Col. Thos Wades Regt. in the State of N. Carolina, Anson County, he was a private soldier and continued in actual service for seventeen months to the best of his recollection, during his said service, he was principally engaged against the forces in the lower part of N. Carolina, and had several skirmishes with them one at Black Creek and another at Betty's Bridge on Drowing [Drowning] Creek, this was in N. Carolina, but what county he can't state. He was under Col Wade for two months. He was then transferred under Col Smith who marched the regiment near Wilmington, N. Carolina, then in possession of the Brittish (sp) Army. The Regt he belonged to were mounted gunmen were stationed in the nighbourhood (sp) of Wilmington to watch the movements of the British Army. Gen Rutherford had the chief command. He continued with the Regt. in that part of the country until a few weeks after the defeat of Cornwallis when they were marched to Anson County and discharged. In this tour he was in actual service fifteen months at least making in all seventeen months of actual service for which he claims a pension.
