Pension application of John Sharp S30702 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June 0.786." Please call errors or omissions to my attention.]

State of Kentucky Scott County Sct. October court 1833

On this 21st day of October 1833 personally appeared in Open Court before the Justices of the County Court aforesaid John Sharpe a resident of said County and State aforesaid and made oath to the following declaration in order to obtain the benefit of the Act of Congress passed the 7th day of June 1833.

John Sharp, he states that he was born in King George [County] in 1764 in February 17th – that he is now going own his seventieth year – He was a resident of Stafford County in the revolution commenced, that he served a tour of duty in the militia in 1780 – during the months of June, July & August under Captain Carey under Colonel James Garret [sic James Garrard], formerly the Governor of Kentucky – that he was marched to Richmond & various other places in King & Queen County until the three months expired – that during the year of 1782 [sic, 1781] during the capture of Corn Wallis [Cornwallis] he again served a mitia [militia] tour of 3 months under Captain William Ballard, under Colonel James Garret aforesaid & Major prim, the tour commenced about the 1st of August & ended after the Siege of York & capture of Cornwallis [October 19, 1781] last of October making three months. Six months in all he has no person to prove these services – he has no record evidence of his birth – he had two discharges but they have been lost he received no pension from any state & are relinquishes all claims except under the Act of 7 June 1832. Signed this 21st of October 1833

[Veteran was pensioned at the rate of \$20 per annum commencing March 4th, 1831, for 6 months service as a private in the Virginia militia.]
