Pension application of Jacob Miller S31258 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Kentucky Sct.

On the 11th of February 1833 personally appeared in open Court before the Justices of the County Court for the County of Harrison in the State aforesaid Jacob Miller a resident of said County and State aged seventy-three years on the 12th of next August who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the Act of Congress passed June 7th 1832.

That in the year 1780 or 1781 as well as I now recollect I volunteered to serve a Tour of three months as a private soldier in the Army of the United States in Captain Gatewood's Company of Light horse which belonged to and composed a part of Colonel Jennings' Regiment of Virginia militia. That I joined the company in Shenandoah County State of Virginia and immediately afterwards we marched to a little village on the Rappahannock River in said state where the British had burnt some houses and had gone off. From that place we marched to hunters Forge or Ironworks where the Company were all discharged. About eighteen months afterwards I volunteered as a private soldier for a Tour of three months in the Army of the United States and was attached to Captain Leehorn's Company of Virginia militia. I joined the Company in Shenandoah County State of Virginia and from there we marched to Philadelphia and there we guarded the British prisoners for almost two months and from there we marched to Winchester Virginia and there we were all discharged. That by reason of old age and consequent loss of memory I cannot state precisely at what time I entered the service or at what time I was discharged but I state positively that I served out my Tour of three months each time. I do not recollect whether I ever got written discharges or not but if I did I have lost them and therefore cannot produce them and I know of no living witness at this time by whom I can prove my services. I hereby relinquish every claim whatever to a pension or annuity except the present and I declare that my name is not on the Pension Roll of any Agency of any State.

The following questions were propounded by the Court 1st Where and in what year were you born? 2nd Have you any record of your age and if so where is it? 3rd Where were you living when called into service: where have you lived since the Revolutionary War and where do you now live? 4th How were you called into service; were you drafted; did you volunteer or were you a substitute, and if in substitute, for whom? 5th State the names of some of the regular officers who were with the troops where you served, such Continental and militia regiments as you can recollect and the general circumstances of your service. 6th Did you ever receive a discharge from the service, and if so, by whom was it given and what has become of it? 7th State the names of persons to whom you are known in your present neighborhood and who can testify as to your character for veracity and their belief in your services as a soldier in the revolution.

To the first I answered that I was born in Shenandoah County State of Virginia on the 12th

day of August 1760

To the 2nd I answered that my age was recorded in my father's family Bible but I have not got it in my possession and do not know where it is.

To the 3rd I answered that I was living in Shenandoah County State of Virginia when I was called into the service and resided there until the fall of the year 1816 when I started to Kentucky and in February 1718 I arrived in Kentucky and have resided in said State ever since.

To the 4th I answered that I volunteered both times but never a substitute.

To the 5th I answered that this question was answered in the Body of my declaration.

To the 6th I answered that I think that I received discharges from the service but I believe they are lost as I cannot find them.

To the 7th I answered that I am known to Lewis Corbin & Abner Haydon in my neighborhood and who can testify as to my veracity and their belief as to my services as a soldier of the revolution.

[p 18: On August 7, 1840 in Harrison County Kentucky, the veteran applied for a new pension certificate saying he has lost his original certificate. This document purports to have been signed by him as follows

[Veteran was pensioned at the rate of \$22.50 per annum commencing March 4th, 1831, for service as a private in the cavalry for 3 months and the infantry for 3 months.]
