I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." I Burtis Ringo in the County of Flemming, in the State of Kentucky do hereby Declare that I enlisted in the Continental Line of the Army of the Revolution for and during the War and continued in its service until its termination, at which period I was a [indecipherable word, ¹] could be intended to be Sergeant] in Captain William Armistead's Company in Colonel Charles Dabney's Regiment of the Virginia Troops, and, I also Declare that I was entitled to receive a Certificate for the reward of \$80 to which I was entitled under a Resolve of Congress passed the 15th of March 1778 and I further Declare that I was not, on the 15th day of March 1828 on the Pension List of the United States

Revolutionary Claims Treasury Department, 16 February 1829

Bontus Ringo [sic] of __ in the County of Flemming [sic] in the State of Kentucky has applied to the Secretary of the Treasury for the benefits of the act, entitled "An act for the relief

of certain surviving officers and soldiers of the Revolution," approved the 15th of May, 1828. He states that he enlisted in the Continental line of the Army of the Revolution, for and during the war, and continued until its termination, at which period he was a Sergeant in Captain __ 's Company, in the Colonel Dabney's regiment of the Virginia (Cavalry) line; and that he received a certificate for the reward of eighty dollars, provided by the resolve of the 15th of May, 1778; and further, that he was not on the 15th of May, 1828, on the pension list of the United States, and that he has received as a pensioner since the 3rd of March, 1826, nothing

The name of Brutus Ringo cannot be found among those of the Virginia line to whom Certificates for the gratuity of \$80 were issued

To the Honorable Richard Rush Esquire Secretary of Treasury of the United States

Sir.

After my Complements to you I wish to make known to you, the reason that Mr. Braxton Pollard was not acquainted with my being or acting as a Sergeant at the time of my discharge from the Revolutionary Army, —

Early in the summer after the capture of Lord Cornwallis at York his Excellency the Governor of Virginia sent to the Commanding officer of the Regiment to which I belonged for a Sergeant and six expert young men that could be depended upon to ride express to convey letters of intelligence to different parts of the union, I was one of the number that was detailed to that important Service and continued in said service about one year, Our Sergeant became dissatisfied in about 2 or 3 months and was liberated to return to the Regiment, at which time I was placed to do Sergeant's duty until discharged –

Our duty was hard in the extreme and we were bound to be always ready either night or day on the business or with the express & had to ride both night & day wet or dry hot or cold whenever called upon which made our task very hard disagreeable and laborious. I am in hopes

your Honor having it in your power will make me some compensation for my service more that the ordinary wages. After my discharge his Excellency kept one by his request about three months for which time he paid me \$20 per month & would have kept me longer but the business being hard & laborious and having serving three years & four months in the regular Army I became tired of the service and wished to return home to my Friends. I was discharged shortly after the ratification of peace. I believe the matter with your honor to do with and disposed of as to you may seem right according to the power vested in you by the laws of our Country.

On this 9th day of August 1832 personally appeared in open Court now sitting Burtis Ringo a native of the State of New Jersey but for most of the early part of his life a resident of Virginia and now a resident of Fleming County Kentucky aged seventy years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7 1832.

That he entered the service of the United States by enlistment in the Army thereof in the latter part of the year 1779 or the beginning of 1780 for during the war, and served in the Virginia State Regiment of light dragoons commanded by Colonel Charles Dabney in Captain William Armistead's Company – he enlisted near Richmond Virginia – was in several skirmishes – one at Williamsburg, the enemy having landed at Burwell's Ferry – one at Jamestown and one at York where & when Cornwallis surrendered in October 1781 [October 19, 1781]. The Regiment of Horse to which he belonged guarded 750 prisoners to Winchester Virginia in January 1782. We were marched to Petersburg Virginia Thence he was with six others (one a Sergeant) detached to ride express for the Governor (Nelson) upon his express requisition – The Sergeant having been unable to perform this duty he (Ringo) acted as Sergeant till May or June 1783 and received his discharge at Richmond from Lieutenant Nathaniel Savage as he thinks – which discharge was [word written over and illegible] by him to Richmond to obtain a him certificate but failed in getting his discharge returned – He hereby relinquishes every claim whatever to a pension or annuity except the present, and he declares that his name is not on the pension roll of any agency whatever.

[Veteran was pensioned at the rate of \$100 per annum commencing March 4th, 1831, for service as a private of cavalry for 2 years 6 months in the Virginia service.]
