I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of Illinois County of Morgan: SS

On this 10th day of September 1832 personally appeared ^{in open Court} before the undersigned Samuel D Lockwood Judge of the Circuit in and for Morgan County now sitting James Wright a resident in the County of Morgan and State of Illinois aged Seventy years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision may by the act of Congress passed June the 7th 1832.

That he enlisted in the Army of the United States in the year seventy seven or seventy eight with Lieutenant Augustin Rucker [Angus Rucker¹] and served in the first Regiment of the Virginia State line under the following named officers, Brigadeer Gen. Millenburg [Peter Muhlenberg] and Col. Gibson [George Gibson] and Maj. Lee and the first two years of which time was under Capt. Nicholas [John Nicholas] and remainder under Capt. Holt [John Hunter Holt], and the said Augustin Rucker continuing Lieutenant during the whole three years, and the time he left the service not recollected but his impression that it was in 1781 or '82 and only under one term of enlistment. At the time of my enlistment I was a Citizen of Culpeper County in the State of Virginia and during the time of my service I was in the battle and fought at Stony Point [July 15 – 16, 1779] & Monmouth [June 28, 1778]. When I entered the service I marched from Culpeper County Virginia down to Williamsburg from thence we marched to Valley Forge and from thence to Philadelphia and from thence into several of the New England states not now recollected and took up winter quarters the second winter at Middlebrook from thence we marched in the direction of Virginia and the particular Towns that we passed not all recollected and finally discharged in Pennsylvania according to the he best of my recollection.

He hereby relinquishes every claim whatever to a pension or an annuity except the present and he declares that his name is not on the pension roll of any agency in any State.

I do hereby Certify that James Wright Served as a Soldier in the first State Regiment, Commanded by Col. George Gibson in the Revolutionary war, for three years being the full term of his enlistment.

Given under my hand this 6th day of March 1803.

Sir I have taken the liberty to inclose to you a Certificate from Capt. Rucker inbehalf of James Wright, a poor wourne out soldier. The perticulars you are acquated with. I hope you will do what you can for the poor man, and inclose it to me by the next post Yr. Compliance will oblige yrs. &c
