[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Tennessee Smith County } This day being the 20th day of August 1832 William Dickson, a resident of the County & State aforesaid about ninety-Seven years old, personally appeared before me Samuel W. McMurray, a Justice of the peace in & for the County & State aforesaid; and said Dickson being first duly sworn, according to law, doth, on his oath, make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed June 7th 1832. ¹

That he is about ninety-seven years old; that he was born in Caroline County Virginia; that he went from Virginia to Orange County North Carolina and was drafted for the term of six months tour; that the troops rendezvoused at a spring near Hillsboro North Carolina; that he was attached to Captain James Thompson's company, and was under the command of Colonel William Moore & General Butler [John Butler]; was at Gates defeat [Battle of Camden, August 15-16, 1780]. That he received a written discharge but it has been lost or mislaid for many years; that he knows of no one now living by whom he can prove his services in the revolutionary war.

He entered the Service in the Spring of the year, but cannot at this time recollect the year, and returned in the fall; that he marched from Hillsboro, by the Hawfields, by the Catawba River etc. etc. that his memory is very treacherous, and can recollect but very imperfectly past transactions, particularly those of so many past years; that he has been blind for upwards of sixteen years, and of course has had but little intercourse with Society, and no opportunity of seeing or conversing with my old brother soldiers.

He hereby relinquishes every claim whatever to a pension or annuity except the present,

¹ The War Department promulgated regulations governing pension application format and requiring the following 7 interrogatories to be put to each applicant for a pension:

^{1&}lt;sup>st</sup> Where and in what year were you born?

^{2&}lt;sup>nd</sup> Have you any record of your age and if so where is it?

^{3&}lt;sup>rd</sup> Where were you living when called into service: where have you lived since the Revolutionary War and where do you now live?

^{4&}lt;sup>th</sup> How were you called into service; were you drafted; did you volunteer or were you a substitute, and if a substitute, for whom?

^{5&}lt;sup>th</sup> State the names of some of the regular officers who were with the troops where you served, such Continental and militia regiments as you can recollect and the general circumstances of your service.

^{6&}lt;sup>th</sup> Did you ever receive a discharge from the service, and if so, by whom was it given and what has become of it? 7th State the names of persons to whom you are known in your present neighborhood and who can testify as to your character for veracity and their belief in your services as a soldier in the revolution.
