*Sussex County ss:/ Personally appeared before me this day Jeremiah Lott who being duly Sworn on the holy Evangelists, deposeth and Saith, that he served in the first troop of the fourth regiment of light dragoons in the Pennsylvania line under Captain Jos. Heard: Colonel Stephen Moylan six years three months as trumpeter to said troop, that previous to this he served one year in the foot under Captain \_\_\_ Dorsey attached to the Pennsylvania line, that he received a wound in South Carolina, in a place called Hunters Bluff, and at Dorchester in South Carolina he \_\_\_ a wound in the head. That near little York previous to the Capitulation of said strife he received a Severe wound in his right shoulder which has in a great measure ever since rendered his incapable of labour owing to the weakness in his right arm, that the would received in his thigh is also very troublesome to him. That he is burdened with a numerous family and would not have been able hitherto to have got along in life had it not been for the benevolence of a humane neighborhood in which he is settled. That the increasing infirmity of age is every day rendering his difficulties greater and his former \_\_\_ more troublesome and father said deponent saith not.*

State of New Jersey Sussex County SS: Personally came before me Thomas Stewart one of the Judges of the court of common pleas &c in and for Sussex County aforesaid Jeremiah Lot now residing in the Township of Greenwich in the County of Sussex aforesaid who being duly sworn upon the Holy Evangelist of Almighty God deposeth & saith, that according to the best of his knowledge and belief he is now in the sixty first year of his age that he is in needy circumstances, that his wife is also Old and very infirm, that they are destitute in a great measure of the means of Support within themselves, that he this deponent enlisted in the Army of the United States on the 18th day of March in the year of our Lord seventeen and seventy-six in the first troop of light dragoons under Captain Herd [sic, Captain John Heard] in the 4th Regiment commanded by Colonel Stephen Miland [sic, Colonel Stephen Moylan] and continued in said troop as the trumpeter year therein until the end of the war and received his discharge therefrom on the 12th day of July in the year of our Lord seventeen and eighty-three, and further saith not.

District of New Jersey, SS

On this Second day of May A.D. 1818, before me the subscriber, one of the Judges of the Court of Common Pleas in & for Sussex County, personally appears Jeremiah Lott, -- aged sixty-one years, resident in Greenwich Suffolk County in this district, who being by me first duly sworn, according to law, doth, on his oath, make the following declaration, in order to obtain the provision made by the late act of Congress, entitled "An act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war:" That he the said Jeremiah Lott enlisted in March 18th 1776 in the state of Pennsylvania in the company commanded by Captain John Herd [sic, John Heard] of the 4th Regiment of light dragoons; that he continued to serve in the said corps, or in the service of the United States until the 12th day of July A.D. 1783, when he was discharged from the service in the state of Pennsylvania, that he was in the battles of Stony Point, Brandywine, Germantown, Chestnut Hill, Trenton, Princeton, Monmouth, Eutaw Springs, &c &c -- and that he is in reduced circumstances, and stands in need of the assistance of his country for support; and that he has no other evidence now in his power of his said services. Sworn to and declared before me, the day and year aforesaid.

State of New Jersey, Sussex County SS

On this fifteenth day of August, in the year of our Lord, 1820, personally appeared in open Court, before the Judges of the inferior Court of common Pleas, holden at

Newton, in & for the said County of Sussex, (which said Court is declared by the Constitution and Laws of the State to be a court of record, with full powers of fine and imprisonment, and unlimited jurisdiction in civil causes) Jeremiah Lott, age 62 years and upwards, -- resident in the Township of Greenwich in said County -- who being duly sworn according to law, saith, that in the year 1776, he was enlisted by Captain John Dorsey, in the first Company of Light Dragoons, attached to the 4th Regiment of the Pennsylvania line, commanded by Colonel Stephen Moylan, -- that he served during the war and said Company as a trumpeter, and was discharged in the year 1783 at Lancaster in the Commonwealth of Pennsylvania; -- as in my original application is more fully set forth, and upon which my Certificate was granted, dated the 12th day of October 1818, numbered (3573.) And he further saith that he was a resident citizen of the United States on the 18th of March 1818, and that he has not since that time, by gift, sale, or in any manner disposed of his property, or any part thereof, with intent thereby so to diminish it, as to bring himself within the provisions of an act of Congress, entitled "An act to provide for certain persons engaged in the Land & naval Service of the United States, in the Revolutionary war." -- passed on the 18th day of March 1818. -- and that he has not, nor has any person in trust for him, any property, or Securities, contracts or debts due to him; nor have I any income other than what is contained in a Schedule, hereunto annexed, and by me Subscribed: -- And this deponent further saith that by reason of two wounds received from a sword, on his right Shoulder and right thigh, and one received from a musket ball on the top of his head, and from very frequent attacks of the Rheumatism, that he is entirely unable to support himself and family, without the aid of Government, or public or private charity, -- that his family consist of himself, his wife named Elizabeth Lott, age 61 years and upwards, very infirm & unable to do anything towards her livelihood, but he is a continual charge to the deponent, -- one daughter named Lavinia Myers, late Lott, who has lately returned to this deponent, with her 3 children, one an infant, another about 2 years, and another about 4 years of age, that they are also a continual charge to the deponent; -- And this deponent further saith that he is by occupation a Sadler, that he does not, nor has he followed the same, since he left the Army, that he occasionally does a little of mending Shoes, but that he does not understand the trade. --
