Pension application of Cornelius Tinsley S3361 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June 1786." Please call errors or omissions to my attention.]

State of Tennessee Sumner County SS

Court of Pleas and Quarter Sessions of the Term of August in the year of our Lord 1832 On this 15th day of August 1832 personally appeared in open Court now sitting in and for the County of Sumner aforesaid Cornelius Tinsley a resident of said County aged 83 years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June seventh 1832.

That he entered the service of the United States under the following named officers and served as herein stated. He was called into service under Captain Dabney at Hanover Virginia and marched from thence to Williamsburg where he was stationed, he was in service three terms of two months each, six months in all under Captain Dabney two months he was stationed at Gloucester being the third term and was discharged at that Point by Captain Dabney a few days previous to the surrender of Cornwallis and that he left his discharge in Virginia.

He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the roll of the agency of any State.

The State of Tennessee Sumner County: SS: Court of Pleas and Quarter Sessions of the Term of November 1832. On this 13th day of November in the year 1832 personally appeared the above named Cornelius Tinsley who being duly sworn deposeth and saith that the year in which he entered the service of the United States mentioned in the foregoing declaration was as near as he can recollect and 1779, 1780 or 1781 he does not recollect exactly how long it was from the time he first entered service until he was discharged – As well as he can recollect during the second term of two months service as a Colonel Goodall commanded he thinks in the neighborhood of Williamsburg Virginia. Applicant was born in Hanover County Virginia and upon looking over the foregoing declaration he is inclined to think he made a mistake in stating "he left his discharge in Virginia" he thinks none received a written discharge. When they were discharged [ink blot obscures the text] Gloucester he thinks upon reflection, that Captain [text obscured] ordered the company to stacked their arms & go home as their times were out. Applicant further states that during the two first terms of service he acted as a corporal & part of the third term he served as a Sergeant and succeeded Sergeant William Hooper and the whole time he was either a corporal or a Sergeant. Applicant further states that Stephen Stone who has certified to the
