Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

New Jersey Sussex County: Personally appeared before me the Subscriber one of the Judges of the Inferior Court of common pleas of said County Charles Stewart an ancient old Soldier, who being duly sworn according to law, on his oath deposeth and saith that sometime in the year of our Lord 1775, he enlisted into the Continental Army as a Soldier under Captain Bull [could by "Ball"] of the 15th Virginia Regiment commanded by Colonel Hennas [sic, James Innis?] of General Woodford's Brigade – that some considerable time after – he was arranged among those by Baron Steuben at the northward & put into the 11th Regiment under Colonel Morgan, and some time afterwards he was put into the 2nd Regiment of the Virginia line commanded by Colonel Febacar [Christian Febiger] – his enlistment was for three years or during the War and was discharged honorably on the 22nd of April in the year 1780 signed by Major Thomas Posey which discharge he has long since delivered to one Benjamin Freeman together with his recommendation from Major Posey for the purpose of getting my bounty Land.

This deponent further saith that he is in the sixty seventh year of his age and is very feeble and infirm and totally incapable of obtaining a comfortable living, that he has an elderly wife to support and has had thirteen children – eight of whom are living, the bringing up of which with many other expenses has always kept him poor and at present under his infirmities, he is really needy & has a just claim on the benevolence of his Country – and further saith not.

To the Honorable the Secretary of War

You will see by the annexed affidavit that I have served nearly 7 years under various regulations as a soldier during the Revolutionary war. I was honorably discharged and I am now poor & needy & too infirm turn my living – under the act of Congress passed March 1818. I pray that I may be put on the pension list – and that I may be informed of the same on the terms of your regulations – as I live in New Jersey. I expect to be enrolled in such way as to receive the same in Jersey.
