Pension application of Nicholas White S33898 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June 1786." Please call errors or omissions to my attention.]

State of New Jersey, Morris County, SS:

Personally appeared before me, Lewis Condict, one of the Judges of the Inferior Court of Common Pleas in and for the said County of Morris, Nicholas White, who being duly sworn, deposeth and saith, that he served in the American Revolutionary War, on the Continental Establishment against the common enemy: That he enlisted at White's Mills, in Berkeley County, Virginia, on or about the 4th day of December in the year 1776 in Captain William Johnson's Company, in the eleventh Regiment of the Virginia line, commanded by Colonel Daniel Morgan; that he served as a Sergeant in said Company and Regiment for more than three years, and was regularly discharged at Kemble's Hills, in Morris County New Jersey aforesaid, on the 15th day of December 1779, by General William Woodford: – that during the said service, he was engaged in the battle at Brandywine, in Pennsylvania, in which he received two wounds, from one of which he now suffers much pain and inconvenience – and at the Battle of Monmouth in New Jersey – besides a number of skirmishes at different places: – That his discharge was lost by an accident some time in the year 1780; and that it is not in his power at present to produce any other testimony of his said services.

This deponent further saith that he resides in the Township of Roxbury, in the said County of Morris: that he is 63 years of age – in reduced circumstances, and stands in need of the assistance of his country for support; that he has never heretofore received any pension from the government of the United States, and prays to be placed on the Pension List, under the act of Congress of the 18th of March, 1818

On this 10th day of July 1820, personally appeared in open Court, before the Judges of the Inferior Court of Common Pleas, Holden at Morris-Town, in and for the County of Morris, in the term of July, in the year aforesaid. [The said court being a court of record, possessing a seal, proceeding according to the course of the common law, having a jurisdiction unlimited in point of amount, keeping records of its proceedings, and it's Judgments being removable by writ of era only] –

Nicholas White aged 65 years, resident in the town of Roxbury in the said County, who being sworn according to law doth on his oath declare, that he served in the Virginia Line in the Regiment commanded by Colonel Daniel Morgan in Captain William Johnson's Company, that he made his original declaration on the 5th day of April A.D. 1818 and that he has received a pension certificate which is numbered 2988,

And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed. That I am aged 65 years by occupation a laborer, but am incapacitated from pursuing my occupation by means of a complaint called the Bleeding piles and also by a rupture in my left groin, and a wound in the left leg received at the battle of Brandywine; that I have a wife named Eleanor, aged about sixty years, who has been for a long time unable to support herself owing to the debility of age and a disease called Phthisic or asthma that I have two children but they do not reside in my family nor are they dependent upon made for support –
