[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention.]

State of Kentucky

I Thomas Montgomery one of the Judges of the Circuit Courts in & for the State aforesaid, do hereby certify, that on the 29<sup>th</sup> day of October in the year 1818, James Rainey aged about sixty-six years, made oath before me that on the \_\_ [date obliterated] day of May in the year 1776, he enlisted in the service of the United States in the war of the revolution against Great Britain, for the term of three years; that he served out the whole war within one or two days of the whole of said term, when he was discharged; but which discharge he has lost not deeming its preservation of any importance: he further stated that he enlisted in the company commanded by Captain Roger Moore, the Regiment was commanded by Colonel Thomas Polk being as well as he recollects the 4<sup>th</sup> and the Brigade was commanded by General Nash [Francis Nash], who fell at the battle of Germantown [October 4, 1777]: He stated further that he believes he was engaged in the Continental service: He stated further that he is in reduced pecuniary circumstances, is really poor & unable to labor much, and stands in need of the aid proposed by the act of Congress of March 1818, and that he desires the same. I certify further that I believe James Rainey has made a true statement of facts according to his opinion. Given under my hand the day & year aforesaid.
