Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June 1786." District of Kentucky: SS:

On this 27th day of April 1819 before me, the subscriber, one of the Judges of the Green County Court for the said district, personally appeared John Riley aged 65 years, resident in Green County in the said district, who, being by me first duly sworn, according to law, doth, on his oath in addition to his former affidavit make the following declaration in order to obtain the provision may by the late act of Congress, entitled "An act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war:" That he, the said John Riley enlisted for the term of twelve months in the month of October or November in the year 1780 in Fairfax County in the State of Virginia in the company commanded by Captain William Mason in the Regiment commanded by Colonel Lucas in the line of the State of Virginia on the Continental Establishment; that he continued to serve in the said Corps, or in the service of the United States, until the end of the time for which he enlisted when he was discharged from service in Prince William County State of Virginia and that he was in no particular battle and that he is in reduced circumstances, and stands in need of the assistance of his country for support and that he has no other evidence now in his power of his said services.
