Pension application of William Yelton S35753 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Kentucky Pendleton District Court July Term 1820 Sct.

William Yelton, a Soldier of the Revolution, this day came into court and delivered in the following written declaration of his services with a schedule of his property thereto annexed viz.: "State of Kentucky Pendleton Circuit Sct. On this 18th day of July 1820 personally appeared in open court, being a court of record by an act of the General Assembly of the State aforesaid, William Yelton aged 63 years, who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the provision made by the act of Congress of the 18th of March 1818 and the 1st of May 1820: That he the said William Yelton enlisted for the term of three years on the day of 1781 in the State of Virginia, in the company commanded by Captain Kilpatrick [sic, Abraham Kirkpatrick?] in the Regiment commanded by Colonel Joseph Dark in the line of the State of Virginia on the Continental establishment; that he continued to serve in the said Corps until the <u>day of</u> 1783 when he was discharged from the said service at Point of Fork in the State of Virginia, as a private soldier: that he was in the battle at the Siege of Little York in Virginia and that he has no other evidence now in his power of his said services except the evidence of John Waller which is hereto annexed, and in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed (to wit)

I am by occupation a farmer, but can with great difficulty make bread for my family, which consists of my aged wife and my daughter aged 27 years, who are unable to assist me.

Deposition of James Yelton,¹ aged 66 – years taken at the Clerk's Office in the town of Falmouth in the County of Pendleton and State of Kentucky on Tuesday the 5th day of February 1822, who being first duly sworn deposeth and saith: That he is and has been ever since and prior to the year 1781, well acquainted with William Yelton (who is now an applicant for a Pension, in pursuance of the acts of Congress of the United States of the 18th of March 1818 and 1st May 1820), that he has personal knowledge of the said William Yelton having been enlisted as a soldier in the Service of the United States, by John Waller, in the year 1781, for the term of three years: That said William, in pursuance of said enlistment, marched and was absent from his place of residence in Virginia until after the termination of the Revolutionary War And that during the period of his absence it was generally reputed and believed that said William was engaged as a soldier on the Continental establishment in the service of the United States: That this Deponent believes, at that time, and does yet verily believe that said William did actually join the Army in the year 1781 and served the United States in the capacity of a soldier in the R. War, in the Virginia line, on the establishment aforesaid, from sometime early in the year 1781 until the termination of the War. And that said William Yelton now & for near 3 years has been a resident of Pendleton County Kentucky. And further this deponent saith not.



State of Kentucky, Pendleton County, to wit:

The Deposition of John Waller² aged sixty-eight years taken at the Clerk's Office in the town of Falmouth in the County aforesaid, on Tuesday the 5th day of February 1822:

This Deponent being first duly sworn deposeth and saith that in the month of in the year 1781 he was a recruiting Sergeant and as such belonged to the company of Captain Kirkpatrick, of the 4th Regiment commanded by Colonel Dark of the Virginia line, on the Continental establishment. That while acting in that capacity he was authorized and employed by General Mulenburgh [Peter Muhlenberg] of the U.S. Army to enlist soldiers in the service of the United States, and did, among others, enlist William Yelton who is now an applicant for a pension, in pursuance of the acts of Congress of the US of the 18th of March 1818 & first May 1820 & whose Declaration & Schedule is hereto annexed as a soldier in the Service of the said United States, for the term of 3 years from the _____ day of ____ in the year 1781; and that said Yelton did actually join the Army and served the US in the capacity of a soldier in the Revolutionary War, immediately after his enlistment as aforesaid until the termination of said War and 1783 when he was discharged at Point of Fork as stated by said Yelton - & further saith not.

[Veteran was pensioned at the rate of \$8 per month commencing July 21st, 1820, for 3 years service as a private in the Virginia Continental line.]
