[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

District of Kentucky Sct.

On the 22nd of May 1818 before me the subscriber one of the Circuit Judges for the Comwth [Commonwealth] aforesaid personally appeared Nathan Young aged 106 years resident in Scott County and District aforesaid who being by me first duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the late act of Congress entitled "an act to provide for certain persons engaged in the land and naval Service of the United States in the Revolutionary War;" That he the said Nathan Young enlisted in the year 1776 in the State of Virginia for 3 years in the company commanded by Captain Rice [George Rice] of the 11th Virginia Regiment in the Continental establishment. That he served upwards of two years in the service of the United States as a Sergeant and was discharged at Valley Forge on account of indisposition to serve the remainder of his time. That he was in the battles of Brandywine [September 11, 1777] and Germantown [October 4, 1777] and other skirmishes and that he is in reduced circumstances, very infirm and stands in need of the assistance of his country for support and that he has no other evidence now in his power of his said services.

[Veteran was pensioned at the rate of \$8 per month commencing May 22, 1818, for two-year service as a private in the Virginia Continental line.]
