Commonwealth of Kentucky Shelby County: Sct. Shelby Circuit September Term 1820

On this 29th day of September 1820 personally appeared in open Court being a Court of common law and criminal jurisdiction for the County and Circuit aforesaid James Spence aged about sixty-five years resident in the County of Shelby in the said State who being first duly sworn according to law, doth on his oath declare that he served in the revolutionary War as follows, that he enlisted for the term of two years & six months in the month of May 1776 in the State of North Carolina in the company commanded by Captain James Jones in the Regiment commanded by Colonel Sumpter, in the Horse service or in the cavalry, that his company was afterwards commanded by Captain Madisec [sic, Cosmo de Medici?] which Regiment was on the Continental establishment he continued to serve in said Corps until the Term of his service expired when he was discharged in the fall or winter 1778. That he was in the Battles of Charlestown South Carolina several small skirmishes etc.

He further states that he made application by his declaration dated the 27th day of June 1818 which was certified by the Honorable Judge Davidge which Declaration was returned for want of proper form, he again made an additional declaration dated 25th day of June 1819 Certified by the Honorable Judge McKee which was also returned for the want of proof of service, which proved he has now been so fortunate as to obtain and has been sworn to by Tallon Embry² of Madison County Kentucky and the oath of Richmond Harris³ of Garrard County Kentucky both of whom know said service and was acquainted with him in his early life etc. He further states that his first declaration was forwarded in company with his second by the Honorable William Logan of the Senate U. S. the first one was either lost or mislaid etc. his second one he now transmits with the proof attached thereto. He further states that he is old and infirm he follows the occupation of Farming but is a cripple in his shoulder and blind in one eye etc. he has a wife who is old and infirm he has four children living with him two sons & two

¹ Given the dates of service claimed by the veteran, I assume this reference is to the first attack on Charleston in the summer of 1776. General Charles Lee was in charge of the Army that defended Charleston at that time.

daughters his sons one about seventeen years of age the other about thirteen his daughters one about twenty-one years of age the other about eight years old his sons is some help to him or he would have to be on the parish for support.

And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed

State of North Carolina Secretary's Office 25th April 1820

The name of James Spence does not appear on the muster rolls, and from his mentioning in his Declaration that he served a part of his time under Captain Medici I have no doubt he belonged to the Cavalry of which there is no roll in this office.

Any Warrant for Western land was issued to James Spence for two and a half years service on the Certificate of an Officer. Given under my hand this 25th of April 1820

Garrard County Kentucky: SCT

This day came Ritchmen Harris of lawful age before me Tyree Harris a justice of the peace in and for said County and made oath that James Spence enlisted in the United States Harmay [army] for 2 years & 6 months in the old Revolution War I was not present when he enlisted but lived in the same Naborhood [neighborhood] But to the best of my understanding he enlisted in the Army the above term named.

Given under my hand this and [indecipherable word or words] 17th day of August 1820

[Veteran was pensioned at the rate of \$8 per month commencing June 27, 1818 for 2 years and 6 months service as a private in the North Carolina Continental line.]
