Pension application of James Suggan S36821 Transcribed by Will Graves f18VA 5/25/12: rev'd 6/30/21

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

## Clarke County State of Kentucky Sct.

James Suggan a Citizen of Bourbon County and State of Kentucky states on oath that he served for three years as a regular Soldier in the Revolutionary War against the common enemy.

That he was entered into the Continental Army in Leesburg, Loudoun County Virginia on the \_\_ day of October in 1775 or 1776, – by Lieut. Morrison [?] in Capt. West's [Francis West's] company of Colonel Rollings' [Moses Rawlings'] Rifle Regiment of the Virginia Line [sic, Maryland Line] Continental establishment for three years. That he was in the Siege of Fort Washington [November 16, 1776], which was taken in 1776 and in several small skirmishes – and after serving out the whole of his said time of three years against the common enemy, was discharged Honorably at Fort Pitt, by Colonel Bell [sic, Major Isaac Beall] in the year 1779 or 1780 – That he is now in reduced circumstances and also getting old and infirm, and is affected in one of his arms by a wound which he got in Service – and is not able to support himself by personal labor. That he is 72 years of age – & his wife nearly as old and quite helpless – He has no Land, and only two cows to support himself & wife, – & no income of any sort, and has heretofore got his living by working days works – which he is no longer able to do – That he has lost his discharge and is unable to make any proof of his services aforesaid other than what will be annexed hereto, and what may be found in the War Department. That in consequence of his indigent Circumstances, he is compelled to ask for the Pension allowed him by law for his Revolutionary Services -

Charles Tracy<sup>3</sup> states on oath that he is well acquainted with the above named, James Sugan [sic], and knows of his own knowledge that he served as is above stated for 3 years in the Continental Army; and that he was honorably discharged – because he saw the discharge, and well recollects it –

John Hedges states on oath that he is well acquainted with the above named James Sugan and is

decidedly of opinion that the statement made by him as to his reduced circumstances is correct and true, and this affiant is of opinion that said Sugan and wife well after a little be supported entirely by the County unless he obtains the Pension allowed him by law.

[Attested June 25, 1818]

In consequence of further proof of Service having been required, and the applicant Referred for that purpose to the Auditor General, Annapolis, Maryland, The said James Suggan from his age, poverty and infirmity finding it impossible for him to make application to the Auditor General has this 18<sup>th</sup> day of May 1819 caused Henry Wiginton [Henry Wigginton]<sup>4</sup> a Citizen of Bourbon County and State of Kentucky, to come before me the subscriber one of the circuit Judges for the State aforesaid – and the same before whom the original declaration was taken, and the said Wiginton being first sworn stated, that he was present at the time and place mentioned by the said Suggan when he enlisted, that he has a perfect and distinct recollection of the transaction and knows that he did enlist in the company and Regiment stated in the said declaration for three years. That some length of time after said enlistment he saw the said Suggan in the Service, and saw him immediately on his return from the Army after his term of Service had expired. The foregoing statements made by the said Henry Wiginton was by him Sworn to before me this 18<sup>th</sup> day of May 1819 I further certify that I am well acquainted with the said Wiginton and that he is a man of good character, and that every credit is due to his statement.

My family consists of myself and wife my wife is an old woman past Labour.

Bourbon Circuit State of Kentucky: Sct.

This 29 day of August 1820 personally appeared in open Court held in and for the Circuit aforesaid being a court of record, James Suggan aged seventy-six years resident of Bourbon County & Circuit aforesaid and being sworn according to law did depose and say that he is the same James Suggan who is inscribed on the pension list roll of the Kentucky agency by virtue of his original declaration dated 25 June 1818 and on which his certificate dated 21 July 1819 and No. 13441 and he did solemnly swear that he was a resident citizen of the United States on the

18th of March 1818; and that he has not since that time, by gift, sale, or in any manner, disposed of his property, or any part thereof with intent thereby so as to diminish it as to bring himself within the provisions of an Act of Congress entitled "An Act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War"; passed on the 18th of March 1818; and that he has not nor has any person in trust for him, any property or securities, contracts or debts due to him; nor has any person in trust for him, any property or securities, contracts or debts due to him, nor has he any income other than what is contained in the schedule hereto annexed – wearing apparel and bedding excepted

[May 13<sup>th</sup>, 1826 in Jefferson County Indiana, the veteran applied for the transfer of his pension payment to the Indiana agency stating that he moved there "for the purpose of residing in the neighborhood of his children who are living in the State of Indiana." He signed this document with his mark.]

[Veteran was pensioned at the rate of \$8 per month commencing June 25, 1818, for service as a private for 3 years in the Virginia Continental line.]

## Kentucky Bourbon County Sct [8 Jan 1822]

James Sugan Appeared before me a Justice of the Peace for said County and made Oath that he Enlisted in Leesburg in Virginia for Three years in the year 1776 in Capt. Francis West's Company of the 4th Virginia Regiment on Continental line Commanded by Col. Rallings and that he continued to serve in service until he was taken prisoner by the British at the Seige of Fort Washington, and he continued a prisoner for a considerable length of time before he was exchanged And after he had served out the Three years for which he was Enlisted, he was honorably discharged at Fort Pitt (now Pittsburg) by Major Bell [probably Isaac Beall VAS2437] of said Regiment and that he has lost his discharge and has never rec'd his Land warrant for said services.
