Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

In the record of proceedings of the Caldwell County Court among others all the following to wit

Be it remembered. At a County Court begun & held in Caldwell County at the Courthouse in the town of Princeton on the 25th day of May 1818

The following proceedings were had to wit

Elijah Veach personally appeared and applied to be heard as an Indigent Soldier of the Continental Revolutionary Army of the United States entitled to the benefit of the law of Congress of the 18th of March 1818 for the relief of such Soldiers, and being duly sworn deposeth and saith, that in January 1777 he enlisted with Lieutenant Springer [probably Uriah Springer] in Colonel Crawford's [probably William Crawford of the 7th VA Regt.] Regiment of Continental troops in the Virginia line in Morganton Virginia for three years that he served three years on that frontier when he was discharged, the proof of which discharge he got recorded in [indecipherable word, <u>might</u> be "Roan" meaning Roane¹] County Tennessee but has lost the discharge, that he afterwards enlisted and served ten months under General Sumpter [Thomas Sumter] and was in the battle of Eutaw Springs [September 8, 1781], Orangeburg [<u>perhaps</u> a reference to the action on May 11, 1781] & Dorchester that he was then discharged but has no copy of it & he further swears that from his reduced circumstances he needs the assistance of his country for support which is ordered to be certified.

Courthouse in the Town of Princeton on Monday the 24th day of July 1820 the following proceedings were had to it

On motion of Elijah Veach he produced in Court his affidavit which being sworn to by him was ordered to be recorded and certified according to law which affidavit reads as follows to wit

State of Kentucky Caldwell County SS: On this the 24th day of July 1820, personally appeared in open Court being a Court of record for said County Elijah Veach aged sixty-five resident in Caldwell County Kentucky who being duly sworn according to law doth on his oath declare that he served in the Revolutionary War as follows: In the 13th Regiment of Virginia Continental Troops that he applied for a pension on the 25th day of May 1818 and that he has received a pension Certificate No. 1291 – And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed, which is one horse worth \$25 one cow worth \$15 one plow and other farming utensils \$12 household furniture worth about \$12, my family consists of a wife 55 years old one daughter 35 years old who is helpless from natural deformity one weakly son 16 years old and an orphan grandson 2 years and 3 months old all of whom are helpless and very little able to assist me by labor. My occupation is that of a farmer at which I am very little able to labor from my age and bodily infirmity. S/ Elijah Veach, X his mark

[p 17: In a letter dated August 1, 1833 sent from Tompkinsville Kentucky by Joel Yancey, request was made that the Commissioner of pensions write to Mr. Elijah Veatch of Tompkinsville and send him the forms he would need to claim the lands do to Virginia soldiers of whom Mr. Veatch is one.]

[p 9: E. D. Veatch² [sic] filed a power of attorney in Mercer County Kentucky on April 11, 1843 in which he states he is one of the heirs at law of Elijah Veach.



[Veteran was pensioned at the rate of \$8 per month commencing May 25, 1818, for 3 years service as a private in the Virginia Continental line.]

State of Kentucky Caldwell County Scct

Elijah Veatch being duly sworn on the Evangelist of Almighty God doth say that Aplicant enlisted at Morgantown in the State of Virginia on or about the 8th day of January 1777 into the company commanded by James Hook [S39713] in the 13th Regiment commanded by Colonel William Crawford [BLWt921-500] in the Virginia line on continental Establishment for the term of three years. that deponant served in the said line until about the 12th day of January 1780 three years from the time of his inlistment when he was Honorably discharged by Colonel John Gipson [sic: John Gibson S41578] at Pittsburg in the state of Pennsylvania that deponant at the time of his discharge was in the company commanded by Uriah Springer [R10017] in the 13th Regiment commanded by Col. John Gipson in Brigadier General Muhlenburgs [sic: Peter Muhlenberg BLWt1495-850] Brigade and General Greens [sic: Nathanael Greene] Division in the virginia line on continental establishment; that deponant lost his discharge about the year 1781 in the affair of Orrangeburg South Carolina; that deponant never received any bounty in land for his service. that deponant is Sixty Eight years of age; was at the time of his inlistment of light complexion, blue eyes, fair hair [several illegible words]

Sworn and subscribed this fourth day of September 1823 before me John Bradley a justice of the peace for Caldwell county and State of Kentucky John Bradley
