Pension application of Nathan White S37535 Transcribed by Will Graves fn26VA 9/10/11

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

## District of Kentucky Fayette County Sct.

On this 15th day of June 1818 before me the subscriber one of the Judges of the Circuit Court for the said district personally appeared Nathan White aged sixty-six years & past resident of said County in the said district, who being by me first duly sworn, according to law, doth on his oath make the following declaration in order to obtain the provision made by the late act of Congress entitled "An act to provide for certain persons engaged in the land & naval service of the United States in the Revolutionary War" That he the said Nathan White enlisted in the winter of 1776 in February in the State of Virginia in the company commanded by Captain Holt Richardson of the 7th Virginia Regiment commanded by General Woodford: that he continued to serve in said Corps in the S. U. S. [Service of the United States?] until the month of February 1779 being three years, when he was discharged from service in \_\_ County State of Maryland, that he was in the Battles of Brandywine, Germantown, (where he was wounded by a buckshot in the right thigh) & Monmouth Court house. That he is in reduced circumstances & stands in need of the assistance of his country for support: That he has no other evidence in his power of his said Services – Having lost his papers & other property by fire.

State of Kentucky Fayette Circuit SS June Term 1820

Be it remembered that Nathan White made oath in open court, and produced a schedule of his property amounting to \$183 agreeably to the act of Congress of the first of May 1820 Concerning Pensions – which is ordered to be entered of record in the words and figures following, to wit;

District of Kentucky SS Fayette Circuit. On this 28th day of June 1820 personally appeared in open Court, being a court of record, for said District and circuit of Fayette County, Nathan White aged 68 years a resident in Fayette County in said District who being first duly sworn according to law doth on his oath declare that he served in the revolutionary war as follows:

He enlisted under Captain Holt Richardson of the 7 Virginia Regiment on Continental establishment commanded by Colonel, afterwards – General Woodford in King William County Virginia in the year 1775, 1776 to serve for three years, continued in service until the expiration of his enlistment, was discharged by Colonel Holt Richardson his first Captain in Pennsylvania – Was in the battle of Brandywine, Germantown where was wounded in the right hip, and at Monmouth Court house. And I do solemnly swear that I was a resident Citizen of the United

States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed. Four horse beasts worth as assessed in my state tax \$100, three cows and calves bought with my pension money heretofore drawn \$30, ten head of hogs mostly small \$12, poultry \$4, farming utensils \$4, kitchen furniture \$7, house furniture besides one bed \$20 = \$183.

I have no Debts due to me, and am indebted towards paying for my cows \$11 and shall owe for rent of my tenement at the end of this year \$63.75 and \$40 for the hire of a servant woman to assist my wife. My occupation is farming on rented land, which I can pursue but indifferently. My wife aged 55 years, my son Benjamin aged 18 years and my granddaughter aged 3 years compose all my family.

[Facts in file: Veteran died August 5, 1834; the family data given in his last application is all of the family data in this file.]

[Veteran was pensioned at the rate of \$8 per month commencing June 15, 1818 for 3 years service as a private in the Virginia Continental line.]
