Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of Ohio County of Union: SS

On this 28th day of June 1833 personally appeared in open Court before the Honorable Judges of the Court of Common Pleas in and for the County of Union aforesaid James Thompson a resident of Millcreek Township in the County aforesaid aged seventy-three years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed June 7th, 1832 that he enlisted in the Army of the United States in the [year] 1777 (he thinks it was though possibly in the year 1778) with Captain Gallant Burley [probably, Capt. Garland Burnley] and served in the sixth Regiment of the Virginia line under the following named officers Colonel Francis Taylor, Major Roberts, Captain G. Burley – Taylor nephew to Colonel Taylor was Lieutenant or Ensign, that he Thompson enlisted to remain during the stay of the prisoners (he believes Burgoyne's men) at Albemarle Barracks in Albemarle County Virginia that he continued in service some months more than three years during which time he was kept Stationed at said Barracks, that he left the service in 1780, that his home then was in Amherst County Virginia that he was serving for a man in Amherst County by occupation a Weaver (his name not remembered) that he enlisted with Burley when serving at the Barracks that he was in no battles during this Service that just before he was discharged he was marched as a guard for the Prisoners to Winchester on this march he passed through Stonestown [Stones Town?] and Millarstown [Miller's Town?] that he received a written discharge at Winchester but now has it not. That he got home in time to be drafted and marched against Cornwallis who then was in Petersburg Virginia that his company rendezvoused at Dandridge's above Richmond he hereby relinquishes every claim whatever to a pension or annuity except the present and he declares that his name is not on the pension roll of any Agency of any State.
