Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

I Joseph Robertson of Northumberland County & State of Virginia do hereby declare I was at the commencement of the Revolutionary war enlisted into the Continental service by George Eskridge a Lieutenant in Captain Edward Hull's [perhaps Capt. Edwin Hull's] Company; that I was marched from the aforesaid County to Dumfries where I was inoculated for the small pox, on recovering from which, I was marched to Valley Forge where I was attached to the 15th Regiment of the Virginia Line, and, as I believe, in General Woodford's Brigade. That I served during the whole war, and at the end of which I was in the 11th Regiment to which I had been transferred, and from which I received an honorable discharge, from under the hand of Colonel Thomas Gaskins of this County under whom I served nearly the whole of the time above specified – That I have lost my discharge – And from the reduced circumstances in which I am at present, greatly [in] need of the assistance of my Country for support.
