Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Georgia Montgomery County: Personally appeared John Talley and after being duly sworn saith that he enlisted in the company of Captain ___ Parsons [William Parsons] of Virginia and was attached to the Regiment of cavalry commanded by Colonel William Washing [sic, William Washington?]¹ At the siege of little York some time in the year 1781, and that he enlisted to serve during the War and he continued to serve during the war, and was discharged at Richmond in Virginia after a final [one or more indecipherable words] sometime in the year 1783 as this deponent believes from the best of his recollection he having no education and that he received a discharge from a Mr. ___ Barrett which discharge has been long since lost or mislaid so that he cannot now procure it or recollect it is contents, and that he is in such indigent circumstances and so disabled by old age and otherwise that he needs the assistance of the General Government for a support.

Revolutionary Claims

Treasury Department 5 January 1830

John Talley Junior of ____ in the County of Perry in the State of Tennessee has applied to the Secretary of the Treasury for the benefits of the act, entitled "An act for the relief of certain surviving officers and soldiers of the Revolution," approved the 15th of May, 1828. He states that he enlisted in the Continental line of the Army of the Revolution, for and during the war, and continued until its termination, at which period he was a Private in Captain Parsons's company, in Colonel Washington's Regiment of the Virginia line; and he received a certificate for the reward of \$80, provided by the resolve of the 15th of May, 1778; and further, that he was not on the 15th day of May, 1828, on the pension list of the United States, and that he has received as a pensioner since the 3rd of March, 1826, nothing.

The Third Auditor is requested to report how far the several statements are corroborated by the records in his office.
