## Pension application of Edward Tenney (Tenny) S38427 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## District of Georgia SS

On this Seventh day of July 1819, before me, the subscriber, one of the Judges of the Inferior Court of Chatham County for the said district, personally appeared Edward Tenney aged sixty-five years, resident in Savannah in the said district, who, being by me first duly sworn, according to law, doth, on his oath, make the following declaration, in order to obtain the provision made by the late act of Congress, entitled "An act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war:" That he, the said Edward Tenney enlisted to serve during the War on the \_\_ day of \_\_ in the year 1778 at Hillsboro in in the state of North Carolina in the company commanded by Captain Henry Bell of the Regiment commanded by Colonel William Washington in the line of the State of South Carolina on the Continental Establishment; that he continued to serve in said corps, or in the service of the United States, until the year 1782, when he was discharged from the service in state of South Carolina, that he was in the battles of the Cow Pens [sic, Cowpens, January 17, 1781], Guilford Court House [March 15, 1781], Camden South Carolina [probably Hobkirk Hill, April 25, 1781] and at Eutaw Springs [May 22-June 19, 1781 he was wounded in between his hand and wrist that he is in reduced circumstances, and stands in need of the assistance of his country for support; and that he has no other evidence now in his power of his said service.

State of Georgia Chatham County: Personally appeared before me Edward Tenney who being duly & solemnly sworn on the Holy Evangelist of Almighty God, deposes and says, that he entered into the service of the United States at Hillsborough in the State of North Carolina in the year 1778 as a private in Captain Henry Bell's Dragoons under the command of Colonel William Washington; that he continued in service until the year 1782, during which time he was in the following engagements, Battle of the Cowpens, Guilford Court House, Camden South Carolina & Eutaw Springs, and that he was severely wounded between his hand and wrist in an engagement with a small party of the enemy at Stono South Carolina which rendered useless two of his fingers and this deponent further states that he is upwards of sixty-five years of age, & that he was born in the State of Virginia. --

Personally appeared before me Henry McCoy who being duly sworn deposes and says, that he is well acquainted with the within named Edward Tenney, and that he was a volunteer in the Dragoons commanded by Colonel Washington, and was present at the Battle fought at Guilford Court House; That he saw the within named Edward Tenney engaged in said Battle in the said Dragoons commanded by Colonel William Washington.

Personally came and appeared before me Moses Sheftall a Justice of the Inferior Court for the County and State aforesaid by lawful authority duly elected, commissioned and sworn, Henry McKoy of Savannah in said County, who being duly sworn deposes and says, that he is well acquainted with Edward Tenney, and that he the said Henry McKoy was a volunteer in the Dragoons commanded by Colonel William Washington, was present at the Battle of Guilford Court House: that he saw Edward Tenney engaged in said Battle as a Private in the Dragoons commanded by the said Colonel William Washington; that he believes that the said Edward Tenney was regularly enlisted in the Continental Service, and served at one tour more than 9 months.

State of Georgia Chatham County: personally came and appeared before me Moses Sheftall a Justice of the Inferior Court of Chatham County in the State aforesaid by lawful authority duly elected, commissioned and sworn, Robert Greer who being duly sworn deposes and says, that he is well acquainted with Edward Tenney and knows that he served as a soldier in the Continental service and that he believes that the said Edward Tenney served therein for a longer period, at one time, than 9 months.
