Pension application of Thomas Turner S39111 Transcribed by Will Graves f32VA 1/3/12

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

and State aforesaid – To all to whom these presents shall come

Greeting. – Know ye that Thomas Turner resident in the District of Laurens & State aforesaid, laborer, did this day appeared & made oath on the Holy Evangelist of Almighty God, that he entered the Army of the United States of America in the Continental Establishment in the American establishment in the revolutionary War, in or about the year 1777 under Captain Thomas Threet [Thomas Thweatt or Thweat¹] of the fourteenth Regiment of Virginia Troops, commanded by Colonel Buford [Abraham Buford], and that he served faithfully, as a soldier until the 12th of May 1780, at which time he was discharged in Charleston in this State by General Woodford. The said Thomas swears that not knowing or anticipating a future value of his discharge, was neglectful of it, & that it is lost. He further swears that from his reduced circumstances in life he needs the Aid of his Country for a Support.

Know ye, that William Irby of the District of Laurens & state aforesaid do make oath by the Holy Evangelist of Almighty God, that for many years I have known the within named Thomas Turner, that he was attached to the same company & Regiment, commanded by Colonel Beaufort of the Continental Troops & that I served with him until I was discharged which was a considerable time. –

State of South Carolina Laurens District

On this 24th day of July 1820, personally appeared in the Court of Ordinary Thomas Turner age sixty-six years, who being duly sworn according to law, doth on his oath make the following declaration in order to obtain the provision made by the Acts of Congress of the 18th of March 1818 and the 1st May 1820. That he the said Thomas Turner enlisted for the term of three years on or about the 1st of May 1777 in the State of Virginia in the company commanded by Captain Thomas Threet [Thweatt], and afterwards by Captain Nathl Terry [Nathaniel Terry] in the 14th Virginia Regiment of Continental troops, commanded by Colonel Lewis, and on his promotion by Colonel William Davis. That he continued to serve in the said Corps until his term of service had expired, when he was discharged from the said Service in Charleston in the State of South Carolina, a few days after the surrender of Charleston to Sir Henry Clinton, and was paroled about the same time as a prisoner of War, which parole is herewith filed signed by Major Stuart. —

That during his service he was at the battles of Stony Point [July 16, 1779], and at Monmouth [June 28, 1778], besides various skirmishes. His discharge is lost, and he has no other evidence now in his power of his said Services except the testimonial of Captain William Irby herewith attached.

And in pursuance of the act of the 1st of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed

He states his profession to be that of a farmer that he has been seized with the Rheumatic pains for the past twenty years, so that he is frequently incapable of using the most feeble exertions for a support. He has only a wife in his family, whose capacity to assist the declarant is likewise feeble. The declarant further states that sometime in June 1818, he forwarded to the War Department vouchers of his having served in the Revolutionary War, & never received an answer thereto. That in June 1819, he again forwarded additional Testimonials, and has received no answer, only that Mr. Tucker the representative in Congress from this Congressional District & State aforesaid has called at the Department of War, found the papers, but that there were some informality's.



I do hereby acknowledge myself to be a prisoner of war, upon my parole, to his Excellency, Sir Henry Clinton, and that I am hereby engaged until I shall be exchanged, or otherwise released there from, to remain at my plantation in the Parish of __County of Halifax & province of Virginia and that I shall not in the meantime do, calls anything to be done, prejudicial to the



success of his Majesties Arms, or have intercourse or hold Correspondence with his enemies; and that upon a Summons from his Excellency, or other Persons having Authority thereto, that I shall surrender myself to him or them at such time and place as I shall thereafter be required.
