South Carolina Horry County: On this 4th day of April 1821 personally appeared in open Court it being a Court of Sessions and Common Pleas for said District Thomas Wallace resident in said District aged sixty-seven years, who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the provision made by the act of Congress of the 18th March 1818 and the 1st May 1820 that he the said Thomas Wallace Enlisted for the term of one year on the 19th day of April in the year 1776 -- in the State of North Carolina in the company commanded by Captain Caswell [William Caswell] -- in the Regiment commanded by Colonel Buncom [sic, Edward Buncombe] -- in the line of the State of North Carolina on the Continental establishment that he continued to serve in the said corps until 16th April 77 when he was discharged from the said service in Halifax County in the State of North Carolina

That he was in no battle during his service and that he has no other evidence now in his power of said services except the affidavit of Joseph Hardee and William Hardee¹ hereto annexed

And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed, one iron pot one dish four plates two knives and forks one ax one hoe one wheel and cards two mugs, he is very unhealthy, has with him in the family his wife Lucy Wallace aged fifty-five she is very unhealthy and in capable of hard labor.

South Carolina Horry District: Personally appeared Joseph Hardee who being duly sworn on the Holy Bible saith that he has just cause to believe and does believe that Thomas Wallace served in the Continental service in the Revolutionary From 1776 when he enlisted in the 5th Regiment in the State of North Carolina for one year and he the deponent further saith he is disinterested in this case.

South Carolina Horry District: Personally appeared before me William Hardee who being duly sworn by me on the Holy Bible saith that Thomas Wallace served in the revolutionary war one year in the Continental service from 1776 to 1777 and he the deponent further saith that he is disinterested in this case.

State of North Carolina Pitt County: This day personally appeared before me Marshal Dickinson one of the Justices of the peace for the County aforesaid John Anderson² who being duly sworn on the Holy Evangelist of Almighty God Deposeth and Saith that he was well acquainted with Thomas Wallace a Soldier in the 5th North Carolina Regiment in the Continental line in the revolutionary war and said Regiment was commanded by Colonel Edward Buncombe and said Wallace was a soldier in Captain William Caswell Company and this deponent further saith that he himself was a Soldier with said Wallace and in the aforesaid Regiment in Captain John Enloes Company and that he believes that said Wallace served the term of 12 months. February 4th, 1822
