# Southern Campaign American Revolution Pension Statements Pension Application of Martin True S39867 M-804 Roll No. 2416 p.940

## Transcribed by Larry Hallstrom

### [Transcriber's Summary

Date and place of birth of Martin True and names of his parents are not shown.

Martin True enlisted in Halifax Co., Va., 22 Apr 1778, served as private in Capt. James Porter's Co., Col. Abraham Buford's Va. Regiment and in Capt Stewart's Co., Col. Davis' Va. Regiment; was in the battles of Savannah, Monck's Corner, Buford's Defeat, Hanging Rock and at the capture of Cornwallis and was discharged 30 Oct 1781.

He was allowed pension on his application executed 15 Feb 1822, at which time he was aged about sixty-six years and resided in Williamson Co., Tn; in 1835, he moved to Madison Co., Tn; and in 1838, returned to said Maury Co., Tn.

In 1822, he referred to his wife as aged about sixty-seven years but did not give her name or the date of their marriage.

Children were referred to: the only name given was that of a son, David H. True, who in 1838 resided in Maury Co., Tn; his age is not shown. A son-in-law resided in Carter's Creek, state not given, in 1822; his name and the name of his wife are not shown and there are no further data as to family.]

### Tennessee

Pleas at Franklin in the county of Williamson, before the Honorable Nathaniel W. Williams one of the Judges of the Judges of the circuit court of Law and Equity for the state of Tennessee at the February term of the said court for the year 1822.

This day appeared in open court Martin True and filed his declaration for the purpose of obtaining a pension with a schedule of his estate thereto annexed, which being subscribed and sworn to in open court, and which said declaration is in the words and figures following (to wit)

District of West Tennessee, on the 15<sup>th</sup> day of February AD 1822, personally appeared in open court it being a court of record by Act of Assembly of the state of Tennessee and circuit court of Williamson County Martin True aged about sixty six years, a resident of Williamson county in said District of West Tennessee who being first duly sworn according to law doth in his oath make the following declaration in order to obtain the pension made by the Acts of Congress of the 18<sup>th</sup> of March 1818 and of the 1<sup>st</sup> May 1820 (to wit) That he said Martin True enlisted in the month of April in the year 1778, as well as he recollects on the 22<sup>nd</sup> day of the said month in Halifax County in the State of Virginia in the company commanded by Captain James Porter, in the regiment commanded Colonel Abraham Buford and Lt Colonel Samuel Hall in the line of the State of Virginia in the Continental establishment, that he said Martin continued to serve in the

said corps until Buford's defeat at the Hanging Rock waxsaw [sic Waxhaws] settlement when he was transferred to Captain Stewart's (company as well as he recollects) Col Davis then in command his former Col Buford having decamped at Buford's Defeat that he said Martin was discharged from said service in Richmond in the State of Virginia in the month of October 1781, he thinks about the 20<sup>th</sup> day of said month, but having lost his discharge some time since he is unable to ascertain the time exactly but is certain it was in October in said year 1781, says he was in the service as a regular soldier three years, and about two years as a volunteer, says he was in the battle of Savannah, Monk's [sic, Moncks] Corner, Buford's Defeat at Hanging Rock on Waxhaws settlement, and finally at the capture of Lord Cornwallis, said Martin says he has no other evidence now in his power of his said services other than his own oath. And in pursuance of the Act of Congress of the 1<sup>st</sup> of May 1820 I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March AD 1818, and that I have I have not since that time, by gift, sale, or in any manner whatever disposed of my property or any part thereof with intent thereby to diminish it so as to bring myself within the provisions of an act of Congress entitled, "an act to provide for certain persons engaged In the land and naval service of the United States in the Revolutionary war" passed on the 18th March 1818 and that I have not, nor has any person in trust for me any property, securities, contracts or debts due me, nor have I any income other than that which is contained in the schedule hereunto annexed and my me subscribed (To wit) One bed and house furniture worth \$14.00 about

And he said Martin True further states that he is not only an old but a very infirm man being often afflicted with Rheumatic pains in his hand and having recently had the misfortune to have his hip much injured, he cannot support himself by his labor, he has no other family except a wife about sixty seven years of age who is also very infirm, his children having left him some years since, says he lives a part of his time with a son in law on Carter's Creek, a part with his son on Snow Creek near the Maury County line, and a part of his time with Allen Hill on Little Warpath, He is by occupation a farmer but is not now able to pursue it Martin his x mark True Declared and sworn to in open court this 15<sup>th</sup> Feby 1822. W Smith? Clerk, which being heard and by the \_\_\_\_\_ is considered by the court that the total amount of value of property exhibited in said schedule is worth the sum of seventeen Dollars and fifty cents and no more and the declarant is worthy of credit.

The following are his reasons for removing from Madison County to Maury Tennessee, were that he was old and desired to live with his son David H. True.
