These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Muskingum County State of Ohio: Sct. Be it known, that before me in the State and County aforesaid personally appeared William Speake & made oath, that he is a resident citizen of this State & that he served as a private soldier in the Army of the United States during the Revolutionary war with Great Britain, that he enlisted in the service thereof on the 10th of July 1777 for three years in Captain Smallwood's [Hebard or Headerd Smallwood's] Company, 16th additional Regiment of Virginia, in the Virginia Line, commanded by Colonel William Grayson on Continental establishment; – that after serving out the service thereof the full term of three years as aforesaid he was discharged at Williamsburg in Virginia by a written discharge signed by Major Stephenson of the United States Army, which is long ago been lost – that he has no other evidence to offer to substantiate his claim to a pension under the late law of Congress; and that by reason of his reduced circumstances in life he is in need of the assistance of his country for support – being now in his 62nd year of his age.

State of Ohio, Coshocton County SS - Court of common pleas of October Term 1821 -

On this 30th day of October A.D. 1821, personally appeared in Open Court, being a Court of Record for said State William Speake aged sixty-seven years resident in Coshocton County in said State, who being first duly sworn according to law, doth on his oath declare that he served in the Revolutionary War on the Continental Establishment, as follows:

In the 16th Additional Regiment, commanded by Colonel William Grayson, Captain Smallwood's Company Virginia line. The date of my Original application is 27 May 1818, and the Number of my pension Certificate is ____

And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed – My Occupation is farming not able to pursue it more than one 3rd of my time – The number of my family residing with me is ____ Their names are as follows: Sarah (wife) and Aaron, Sarah afflicted with the Consumption – Their ages as follows: Sarah 52 – Aaron 18 years – That capacity to contribute to my Support but very small, principally dependent for Support of my relations, Sworn and Subscribed –

To all whom it may concern

Being solicited by Mr. William Speake, who states that he enlisted in Colo. William Grayson's

Regiment and was afterwards transferred to the 3^d Virginia regiment, to certify relative to his having regularly and fully served as a soldier in said regiment – not having been acquainted with him during the revolutionary war, cannot positively state any thing concerning his service; but am well satisfied, from his minute and circumstantial detail of almost every important circumstance which transpired a the Siege of Charleston, that he belonged to the Virginia troops that capitulated there [12 May 1780] and that (as he states) he was discharged at James Town ["Williamsburgh" interlined] about the 1st of Aug't 1781 and enlisted on the 10th of July 1777. I can further state it as my opinion that he is an industrious honest and upright man and is worthy the attention of every person who is disposed to [illegible] the [undeciphered word] of an old soldier. Given under my hand the 20th day Sept 18[??]

I do hereby certify that I was in the Regim't of Colo Grayson and was personally acquainted with above soldier Wm Speake from 1777 to 1779 when I left the Regim't but believe that he served faithfully as is stated being myself later at Charles Town and attended the exchange above mention'd

Given under my hand this 2^{nd} day of Nov 1812.

I do hereby certify that I enlisted in the [undeciphered] of the [several undeciphered words] Col William Grayson and marched on to the Northward and joined the army at white [several undeciphered words]. the most of my service in the Northern states of Pennsylvania east & west Jerseys state of new York and connecticut & then was transferred out of the 16th regiment into the Third Virginia Regiment & was then sent on to the southward under the command of General [William] Woodford in order to reinforce General [Benjamin] Lincoln [illegible] besieged at that time by the British in Charlestown south Carolina & was taken prisoner there at the seige may the 12th 1780 I there remained a prisoner of war untill [sic] Lord Cornwallis and his army were taken at York in Virginia [undeciphered] 1781 [19 Oct 1781], and then was put exchanged[?] on board a [several undeciphered words] to the capes of Virginia and was landed a at Jamestown Virginia & from thence marched to Williamsburg and there was discharged from the service of the United States and have since lost my discharge.
