[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

On this 15th September 1818 before may the Subscriber one of the Judges of the General Court of the State aforesaid, personally appeared Thomas Wilkinson aged sixty years resident in Dinwiddie County in the said District who being by me first duly sworn according to Law doth on his Oath make the following declaration in order to obtain the provision made by the late act of Congress entitled "an Act to provide for certain persons engaged in the land & naval service of the United States in the revolutionary war:" That the said Thomas Wilkinson enlisted on the 15th day of December 1776 in the State of Virginia in the Company commanded by Captain James Mason of the 15th Virginia Regiment under Colonel David Mason, that he continued to serve in the said Corps or in the Service of the United States until the first January 178 [last digit run off the page and are illegible, could be 1783] when he was discharged from service in Philadelphia: that he was in the Battles of Brandywine [Sept. 11, 1777], Germantown [Oct. 4, 1777] & Monmouth [June 28, 1778] and that he is in reduced circumstances & stands in need of the assistance of his Country for support: And that having lost his discharge when his house was burnt he has now no other evidence of his services but the Certificate of his Captain hereto annexed & the corroborative testimony of Henry Brown. Sworn to & declared before me the day & year aforesaid.

On this 19th day of June 1820 personally appeared in open Court in the County of Dinwiddie, Thomas Wilkerson [sic], aged Sixty three years, resident in Dinwiddie County in said District, who being first duly sworn according to law, doth, on his oath, declare that he served in the Revolutionary War as follows. In the 15th Regiment & in a company of Infantry commanded by Captain Joseph Mason; the original declaration is dated the 15th of September 1818; that he has only received on account of my pension \$44.53, which pension Certificate is dated the 15th of September 1818 and is numbered ______. – And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed

The afidavit of Williamson Smith of lawfull age and duly sworn states he was acquainted with Thos. Wilkerson now of Dinwiddie who served 3 years in the Virginia line on continental establishment That he was in Capt. James Mason's company fifteenth regment and that there was another Thos. Wilkerson (father of the said Thomas above named who enlisted in the service and died. 30th of Sept 1830 [Sussex County]

City of Richmond sct. This day Thomas Wilkerson personally appeared before me a magistrate of the said city, and made oath, that he served three years as a soldier of infantry in Capt. James Mason's company 15th Regiment of the Virginia line on continental establishment. That his father Thomas Wilkinson sen'r. also served 3 years in the same company & Regiment – and that he this affiant hath never received his warrant for land bounty. Given under my hand this 8th day of october 1830.

The petition of Thomas Wilkerson humbly represents that he is now entitled to receive his warrant for his land bounty as a soldier of infantry in Capt Mason's company 15th Virginia Regiment on continental establishment and exhibits above, the grounds of his claim and herewith lays before the executive the evidence above referred to and prays an order of council directing the Register to issue his warrant for land bounty.

I certify that it appears from a list of such of the names of the Soldiers of the Virginia State line on Continental establishment as received certificates for the balance of their full pay agreeably to the act of Assembly passed the November Session 1781 that a certificate issued on the 12^{th} day of November 1783 in the name of Thomas Wilkinson a soldier of infantry for £54.11.8 – which certificate was delivered to Col. Mason. I also certify that it appears by the said list that a certificate issued on the 26^{th} July 1784 in the name of Thomas Wilkerson Sen'r a soldier of infantry for £26.16 and that the said certificate was delivered to Ed Valentine.

Given under my hand at the Auditors Office 8th Octo. 1830/ Jas. E. Heath, APA
