Pension application of John Willis S41351 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June 1786." Please call errors or omissions to my attention.]

At a Court of Quarterly Sessions continued and held for Louisa County on Wednesday the 14th day of June 1820 –

District of Virginia to wit

On this 14th day of June 1820 personally appeared in open Court (being a Court of record for the County of Louisa) – John Willis aged sixty-two years who being first duly sworn according to Law – doth on his oath make the following declaration in order to obtain the provision made by the Acts of Congress of the 18th of March 1818 and the 1st May 1820 that, he the said John Willis enlisted for the term of three years on the __ day of __ in the year 1777 in the State of Virginia in the company commanded by Captain Mucklehany [probably Captain] James McIlhaney] in the Regiment commanded by Colonel Brent [probably Colonel William Brent] in the line of the State of Virginia on the Continental establishment: that he continued to serve in the said Corps until 1780 when he was discharged from the said service in the Jersies, that he then enlisted again for during the war on the day of in the year 1780 in the Jersies in the Company commanded by Captain Winston [John Winston] in the Regiment commanded by Colonel Davis [William Davies] in the line of the State of Virginia on the Continental establishment. That he continued to serve in the said Corps until [illegible] when he was discharged from the said service in the State of Virginia (pace being then concluded). That he was in the Battles of Stony Point at the siege of York – and that he has no other evidence now in his power of his said services –

And, in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed

The following is a true schedule of all my estate (necessary clothing and bedding excepted) viz.

One horse, one cart, seven chains, two axes, three hoes, one plow, one pair of traces, one spinning wheel, one dozen knives & forks, – that I am a farmer but weak and infirm and unable to pursue my occupation with any prospect of a support – that I have a wife named Sarah about fifty years of age – who is very sickly and unable to render me any assistance – that I have no other income.

Louisa County [Virginia]

This day Walter Austin¹ came before me a Justice of the peace in the above County and made oath that he is well acquainted with John Willis that they both served under Captain Winston [John Winston] in the Regiment commanded by Colonel Davis [William Davies] in the line of the State of Virginia on the Continental establishment and that said Willis continued in the Service until peace in 1783 given under my hand and seal this 20th day of October 1823. S/ Charles Dabney, JP

Hanover County [Virginia]

This day Hensley Grubbs² came before me a Justice of the peace in the above County and made oath that he is well acquainted with John Willis that they both served under Captain Winston in the Regiment commanded by Colonel Davis in the line of the State of Virginia on the Continental establishment and that he Willis continued in the service until peace in 1783. Given under my hand & seal this 14 day of January 1823. S/ Lewis W Taylor, JP

[Veteran was pensioned at the rate of \$8 per month commencing October 20, 1823, for 3 years service as a private in the Virginia Continental line.]
