Pension application of Paul Wright S41383 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Powhatan County State of Virginia

On this 12th day of May 1818 before me the subscriber one of the judges of the General Court of Virginia, and Judge of the Superior Court of law for Powhatan County personally appeared before me Paul Wright aged sixty-three years, resident in the aforesaid County of Powhatan, who being by me first duly sworn according to law, doth on his oath make the following declaration in order to obtain the provision made by the late Act of Congress entitled "an Act to provide for certain persons engaged in the land and naval service of the United States during the Revolutionary war."

That he the said Paul Wright enlisted in the first Virginia Regiment John Markham Captain for one-year early in the Revolutionary war, that after serving his time as a common soldier, he was discharged, but through lapse of time he has no copy of his discharge now in his possession – that he afterwards enlisted in the 10th Virginia Regiment Captain Hughes Woodson Company, for the period of three years, as a common soldier, during which time he served, and was discharged at Trenton in the State of New Jersey; but discharge also from the foregoing cause he has not now in his possession. That he was at the Battle of Stony Point [July 16, 1779]; as one of the out guard, and joined the main Army of the United States the day after, or in some short time, after the battle of Monmouth [June 28, 1778]; but was not actually in the engagement; and that he is in reduced circumstances and stands in need of the assistance of his Country for support; and that the only evidence besides his own declaration now immediately in his power is the annexed affidavit of his fellow soldier Peter Francisco, who is well known throughout Virginia.



Cumberland County Virginia – this 27th day of April 1818, Peter Francisco¹ appeared before me and made oath that he knew Paul Wright now of Powhatan in the Continental Army of the American Revolution, and he believes that said Paul Wright served for the period of three years in the 10th Virginia Regiment as a common soldier to which Regiment this affiant was also attached – That the said Wright was in Captain Hughes Woodson's company & certainly was in the Army several years, this affiant thinks at least three –

Virginia, Powhatan County to wit:

On this 21st day of September in the year 1820 personally appeared in open Court in the County Court of Powhatan in the State aforesaid being a Court of Record according to the Constitution and laws of this state, Paul Wright, aged sixty-five years, resident in said County, who being first duly sworn according to law, doth on his oath declare that he served in the Revolutionary war; viz.: in the 10th Regiment Captain Hughes Woodson's Company of the Virginia line, as appears by his original declaration dated the 18th day of May 1818 and transmitted to the War Department of the United States, and that he has received a pension of accordingly and a certificate was issued to him by the Secretary of War, dated the 12th day of September 1819, and numbered 14730, which said certificate is now exhibited in open Court for the inspection. And the said call right solemnly made oath that he was a resident Citizen of the United States on the 18th day of March 1818 and that he has not since that time by gift, sale or in any manner whatever disposed of his property or any part thereof with intent thereby so to diminish it as to bring himself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that he has not nor has any person in trust for me any property, or securities, contracts or debts due to him nor has he any income other than what is contained in the schedule mentioned hereafter and by him subscribed: that he has no family whatever, that he is by occupation a carpenter but that he is totally unable to pursue said occupation, and that he is in such indigent circumstances that he cannot support himself except he obtained aid from his country; -

The Schedule mentioned above is as follows, to wit; "State of Virginia, Powhatan County, September the 21st 1820. Schedule of the property of Paul Wright: I have no property of any kind except my wearing apparel; nor have I any income whatever except what my country may allow me.

Signed Paul Wright, X his mark"

[Veteran was pensioned at the rate of \$8 per month commencing May 12, 1818, for 3 years service as a private in the Virginia Continental line.]

[From bounty land records in the Library of Virginia]

Paul Wright (Soldier) in the 6^{th} Virginia Regiment having faithfully served three years the term of his inlistment is hereby discharged & commissaries are desired to furnish him with provision till the 8^{th} day of January next.

Given under my hand at Trenton this 18th day of December 1779 S/ Samuel Hawes Lt. Col. Comdt. 6th Virg. Rgt. S/ N. Gest Colo. Comdt M. B. G.
