State of North Carolina & District of Edenton Pasquotank County

On this nineteen day of April 1819, before me, the subscriber, one of the Judges of the Superior Court of Law & Equity for the said district, personally appeared John Rogerson aged 65 years, resident in Perquimans County in the said district, who, being by me first duly sworn, according to law, doth, on his oath, make the following declaration, in order to obtain the provision made by the act of Congress, entitled "An act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war:" That he, the said John Rogerson enlisted for the term of 3 years on the 4th day of May in the year 1777 [last digit unclear and uncertain] in the town of Hertford in the State of North Carolina in the company commanded by Captain Isaac Moore of the Regiment commanded by Colonel Abraham Sheppard in the line of the State of North Carolina on the Continental Establishment; that he continued to serve in said corps, or in the service of the United States, until the twenty fifth [?] of May 1780, when he was taken prisoner at Charleston in Charleston and that he is in reduced circumstances, and stands in need of the assistance of his country for war; and that he has no other evidence now in his power of his said services, except the affidavit hereto annexed.
