Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Jeremiah Williams maketh oath, after being duly sworn, that in the year 1782, he entered the Service of the United States in the Company of Captain William Lytle in the North Carolina Regiment & North Carolina Line – that he served until after the peace in 1783 when he was readily discharged – He further swears he is an indigent circumstances & in need of the aid of his Country.

On this 17th day of October 1820, personally appeared in open Court, being a court of record of said County of New Hanover Jeremiah Williams aged 60 years a pensioner & resident of said County of New Hanover, who being first duly sworn according to law, doth on his oath declare that he served in the Revolutionary War as follows to wit in Captain Rhody [Joseph Thomas Rhodes] Company of the 3rd Regiment of the North Carolina line of the Continental Army commanded by Colonel Lytle [Archibald Lytle] for the term of Eighteen months. The date of the original declaration not recollected – the number of the pension Certificate in my Possession 5270

And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or otherwise disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income whatsoever, & nothing but my necessary clothing, being by calling a Farmer but unable to work, having no family. I live part of my time with a
