
Pension Application of Naniad (Neniad) Coleman S42657

Personally came before the undersigned one of the Associate Judges of the Court of Common Pleas in and for the County of Hamilton Neniad Coleman residing in the said county who being duly sworn according to law depose and saith, that some time in the Autumn of the year 1776 or beginning of 1777 he enlisted at Leesburgh in Virginia in Captain John Ashby's company of the 3rd Virginia Regiment upon Continental Establishment to serve for three years – that he served in the company commanded by the said Ashby, and afterwards by Volentine Peyton [sic: Valentine Peyton], who succeeded to the command in consequence of Capt Ashby's being wounded, and left the service. That he served in the Regiment aforesaid commanded by Col. William Heath [sic: William Heth] until he was discharged on the 10th day of December 1779 a few days before the three years, the period of his enlistment had expired, in consequence of being disabled by the rheumatism. And this deponent further depose and saith, that now in consequence of his advanced age (being in the 72nd year) bodily infirmities, and reduced circumstances he stands in need of the assistance of his country for support and further saith not

ON this 30th day of August 1820 personally appeared in open court, being a court of record for the said County Neniad Coleman aged Seventy five years resident in said County who, being duly Sworn according to law, doth on his oath declare, that he served in the revolutionary war, as follows, that he the said Neniad Coleman enlisted for the term of three years in the year 1777 in the state of Virginia in the company commanded by Captain John Ashby in the regiment commanded by Colonel [Thomas] Marshall in the line of the state of Virginia on the continental establishment. That he continued to serve in the said corps until the year 1780 when he was discharged from the said service near Morristown in the state of New Jersey that his original declaration was dated on the 29th day of September 1818 that he has received a pension certificate, given at the War Office of the United States on the 29th day of October 1809 which said certificate is numbered 15,633. And in pursuance of the act of the 1st May, 1820, I do solemnly [blank] that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of an act of Congress entitled "an act to provide for certain person engaged in the land and naval service of the United States in the Revolutionary War" passed on the 18th day of March 1818 and that I have not nor has any person in trust for me any property or securities contracts or debts due to me nor have I any income other than what is contained in the Schedule hereto annexed and by me subscribed. And I further declare that I have been by occupation a farmer but that I am now superannuated and unable to follow any kind of business; that I have a Wife living who is allmost as old and helpless as myself; I have three Children who are of age and capable of maintaining themselves; and one son now forty five years of age who is an Idiot and incapable of doing any thing towards his support, and has ever been a charge to me. I declare that I stand much in need of assistance from my Country for support

NOTE: On 6 October 1819 Mary Coleman stated that she had been acquainted with Naniad Coleman for about 15 or 16 years before 1776 and knew that he enlisted in Leesburg in 1776 for three years and except for a brief furlough was absent from home for that period.
