Pension application of Bernard (Barabay) Thompson¹ S46508 f29**MD**/VA Transcribed by Will Graves 12/4/11

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

For the purpose of obtaining the benefit of the act for the relief of certain surviving officers and soldiers of the Army of the Revolution approved on the 15 of May 1828 I Bernard Thompson of the County of Washington & State of Kentucky do hereby declare that I enlisted in the Continental line of the Army of the Revolution for three years and continued in its service until its termination at which period I was a private in Captain ___ Brown['s Company] in the Regiment of Colonel Warner² [?] of the Maryland line. And I do also declare that I afterwards received a certificate for the reward of \$80 to which I was entitled under a resolve of Congress passed the 15 of May 1778.

And I further declare that I was not on the 15 of day of March 1828 on the Pension list of the United States.

Revolutionary Claims Treasury Department, August ninth, 1828

Bernard Thompson of __ in the County of Washington in the State of Kentucky has applied to the Secretary of the Treasury for the benefits of the act, entitled "An act for the relief of certain surviving officers and soldiers of the Revolution," approved the 15th of May, 1828. He states that he enlisted in the Continental line of the Army of the Revolution, for and during the war, and continued until its termination, at which period he was a private of Dragoons in Captain __ 's Company, in the De Armand's Corps; and that he received a certificate for the reward of eighty dollars, provided by the resolve of the 15th of May, 1778; and further, that he was not on the 15th of May, 1828, on the pension list of the United States, and that he has received as a pensioner since the 3rd of March, 1826, nothing.

[Having been enlisted in the Maryland he styles himself of the Maryland Line]

State of Kentucky County of __: SS

I Bernard alias Barabay Thompson aged Sixty-seven years, do, upon oath, testify and declare, that about or in the year 1781 I enlisted or entered the service as a private for the term of "during the war," in the Regiment, commanded by Colonel Armand [Charles Armand, Marquis de la Rouerie³] and afterwards served in the same Regiment under the command of Colonel Armand and that I continued in the service aforesaid until the close of the war, when I was regularly discharged from the same Corps or Regiment, command by Colonel or General Armand composed of all the lines and when I was a Private Dragoon my discharge I have lost; that when I entered the service in Captain Brown's Company, I was a resident of Virginia, within the County of __ and that whilst in the service although my proper name is Bernard, I was known as and called Barabay by both the officers and soldiers.

I further declare, that I have never received a warrant for the Bounty land promised me on the part of the United States; nor have I ever assigned or transferred my claim in any manner whatsoever

Therefore know all men by these presents, that I Bernard alias Barabay Thompson aforesaid do hereby constitute and appoint Captain John Kincaid member of Congress to be my true and lawful attorney, for me and in my name, to demand and receive from the Secretary of War of the United States, a warrant for the quantity of Land due to me as aforesaid; and my said attorney is hereby fully authorized and empowered to constitute and appoint one or more substitutes or attorneys under him for the special purposes above mentioned.

In witness whereof, I have hereunto affixed my hand and seal this 25th day of November A.D. 1830.
