State of Virginia Monroe County SS

On the 22 day of August 1832 personally In open court (for said county) now siting Samuel Sams a resident of Virginia in the County of Monroe aged seventy four years who being first duly sworn according to said doth on his oath make the following declaration, in order to obtain the benefit of the act of Congrefs pasfed June 7th 1832. That he entered the service of the United States Under the following named officers and served as herein stated.

That he substituted and served six months in the malitia for one William Dickey who was drafted from the County of Augusta in the State of Virginia some time in the year 1780_he thinks in the latter part of the same year at which time he was a resident of the County of Augusta in the State of Virginia he served under Capt.

James Tate commanded by Major Frank Triplet [Francis Triplett]

Who was from the County of Fauquier in the State afo

re said the regular officers were Col. Howard [John Eager Howard], Major

Brooks and Genl. Morgan [Daniel Morgan] he marched to South Carolina and was in the Battle of the Cowpens

in January 1781. That he was with a company when

Col Washington [William Washington] took about one hundred Torys

prisoners at Rugleys Mills [Rugeley's Mill, December 4, 1780]_he marched to Salsbury [Salisbury]

in North Carolina and was discharged at that

place After returning home he was drafted for

a three month tour in June 1781 as he believes from the

said County of Augusta his Capt. was John Campbell,

Col Cameron [Charles Cameron] and Maj. Long. He marched to the

lower part of Virginia and was at the siege of

York in the fall of the year 1781. That he was one

of the troops who guarded the prisoners to near Winchester and when he arrived there he was discharged He was in the Battle of Jamestown where he was commanded by Capt John Dickey, Col Huggart [probably Col. Thomas Hugart or Hughart] some time after went home, when Col William Bowyer took the command That he in the year of 1782 substituted and served in the malitia for three months in the room of Hugh Brown of the County of Augasta against the Indians under Lieut. John M^c Camey ?- and marched to the head of Greenbrier to a place called Clover Lick, and there served out his time during which he was in no Battle he knows of but one man who has any knowledge of his ser vice in the south his name is Berryman Jones and resides in the County of Greenbrier who was in the same company and from the same county, he knows of no proof as to his other service except at the Battle of Jamestown Samuel Clarke who was from the said County of Augusta was in the Battle and he was acquainted with him and believes that he will testify of the fact He hereby relinquishes any claim whatever to a pension or anuity except the present and declares that his name is not on the pension roll of the agency of any state whatever

We James Cristy Clergyman residing in the County of Monroe and State of Virginia and Samuel Clark residing in the same County and State do hereby certify that we are well aquainted with the above declaration that we believe him to be seventy four years of age that he is reputed and believed to have been a Soldier of the Revolution and that we concur in that opinion

Berryman Jones appeared in open court and after being sworn as the Law directs deposeth and saith that Samuel Sams who is now before the

Court and whos declaration in order to obtain the benefit of the Act of Congress passed June 7th 1832 was in the service of the United States in the Revolutionary War that he was aquainted with him, and knew him in the service, that he marched with him from the Country of Augusta in the State of Virginia to South Carolina under the command of Capt. Tate of the Militia when we arrived there we were placed under the command of Genl. Morgan that he knows said Samuel Sams was at the Battle of the Cowpens. that the next day after the Battle a detachment of men were ordered to take charge of the prifoners under the command of Maj. Trifield and that Samuel Sams in the Service afterwards with himself were in the detachment until they arrived at Salsbury North Carolina. He Jones was discharged at the Maravian Town [Moravian Town] and did not see Sams in the service afterwards and further that his Term of service was six months and also the term of Samuel Sams and the time of entering the service was he believes in the latter part of the summer of 1780

Samuel Clarke a witnefs after being sworn deposeth and saith, That he said Clarke in the year 1781 was called into the service a three month tour in the Militia from the County of Augusta in the State of Virginia in the month of May or June of said year and that he knew Samuel Sams in the service at that time and continued to know him until the Battle of James Town at which time he said Clarke was wounded and was sent to the hospital and did not see said Sams afterwards during the time of service he does not know which captain commanded the company to which Sams belonged but he knows his Maj. Wilson to be Wilson and his Col. Thomas Huggart and that he knew Huggart went home

and that during the time Col William Bowyer took the command at the Battle of Jamestown and was taken prisoner he did not see Sams at the Seige of York but has every reason to believe he was there being aquainted with him for forty years and having had frequent conversa tions with him upon the subject and further believes him to be an honest man worthy of belief in oath

And the said Court do hereby certify and declare their opinion after the investigation of the Matter and after putting the interogatories prescribed by the war department, That the above named Samuel Sams (applicant) was a revolutionary Soldier and served as he states_ and the Court further certifies that it appears to them James Cristy who has signed the preceding certificates is a Clergyman resident in the County of Monroe and that ______ who has also signed the same is a resident of said county and is a credible person and that their statement is entitled to credit.
