[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an

aid to research, not to be used in lieu thereof.]

On this 5 day of December 8 1836 James Withrow a Soldier of the revolution aged 72-10th of June last personally appeared in open court and made the following declaration in order to attain the benefit of the act of Congress passed the 5th of June 1832 [sic, 7th June 1832]. Applicant says in 1780 he was drafted into the service of the United States for three months in Burke County North Carolina in Captain John Sickman's [John Sigman's] company Colonel Charles McDowell commanded the Regiment Captain Sickman organized his company in Burke County and marched to Broad River the object of the expedition was against Ferguson [sic, Major Patrick Ferguson]. Colonel Ferguson did not come to where Colonel McDowell was stationed but attempted to get round him. McDowell then retreated to Burke from thence he marched towards Gilbert town to meet Ferguson they met at the head of Cane Creek between these two points and we were defeated had one man killed Peter Branks [?] and Captain Joseph White wounded. We retreated from thence across the mountains to the western waters where we remained until reinforcements could be collected when we returned in company with Colonels Shelby [Isaac Shelby], Campbell [William Campbell of Virginia], Sevier [Lt. Col. John Sevier] to east of the mountains and went in pursuit of Colonel Ferguson. Applicant in crossing the mountains lost his horse and was left by the balance of his company who rapidly pursued Ferguson to Kings Mountain, he followed on with the footman as fast as they could but did not get up in time to participate in the Battle on the next day we met our troops returning near the Broad River with the prisoners. We marched to Green Lees [Greenlee's Ford, Morganton NC]² on Catawba River Burke where affiant was discharged and went home. On his return home he met with a company of Whigs and joined them and went in pursuit of some Tories who were collected at Isaac Martin's in said County. We dispersed them and went home. We were engaged 3 or 4 days in this expedition. Applicant again entered the service of the United States as a soldier in Captain William Penny's company in 1781 for three months we marched to Wilmington and were discharged after the surrender of Cornwallis [Yorktown, Oct. 19, 1781] having served eight weeks which will appear from the affidavit of John Lowery accompanying this declaration. In March 1782 he volunteered to go against the Indians in Captain Daniel Whitener's company

Major Jo. McDowell [then Lt. Col. Joseph McDowell] was commander assembled in Burke County and marched west of the mountains and scoured the country and dispersed the Indians and returned home having been engaged between 10 and 15 days. In August 1782 entered the service in Captain James Wilson's company [Rutherford County, NC] the whole commanded by General Charles McDowell Colonel Joseph McDowell commanded our Regiment organized in Burke County and marched to the Cherokee nation the Indians Out of our reach we were engaged in this expedition 20 or 25 days we were discharged and returned home never entered the service afterwards has no documentary evidence of his services nor is there any person living by whom he can prove his services except the 2nd tour by John Lowery he hereby relinquishes all claim or claims to a whatsoever to a pension or pensioners except the present and declares his name is not on the pension roll or agency of any state.

[p 9: In a letter dated March 11, 1850 from the Treasury department, 3rd Auditors Office, \$20 was remitted to Miss Jane Withrow as administratrix of the estate of James Withrow in payment of the arrears of his pension due from September 4, 1847 to September 4, 1848. The Auditor also authorized her to receive the balance due to August 14, 1849 upon the surrender of the pension certificate. Presumably, the veteran died on August 14, 1849. Her relationship, if any, to the veteran is not disclosed by the documents in this file.]

[Veteran was pensioned at the rate of \$20 per annum commencing March 4th, 1831, for 6 months service as a private in the North Carolina militia.]
