Pension application of James Willis S6417 Transcribed by Will Graves fn10VA 9/28/11

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

Virginia, to wit:

On this 29th day of November 1832 Personally appeared before the Court of the County of Halifax, James Willis, a resident of the County and State aforesaid, aged sixty-eight years: who being duly sworn according to Law doth on his oath make the following declaration in order to obtain the benefit of the Provision made by the Act of Congress passed the 7th of June 1832. This applicant states that he thinks it was about the year 1779 he entered the service of the Revolutionary War, under the command of Captain Kendrick [possibly Capt. John Kendricks], and marched with Captain Mabrey & Lockett's Companies to Petersburg and from thence to Smithfield & to Suffolk was transferred to the Infantry, – marched to the Dismal Swamp and from there marched to Sticky Hole ferry on Nansemond River, and from thence to Black-water and was discharged at that place of one tour of three months, that he was a second time drafted and marched under Captain Jeffres, crossing James river at Hog Island to Williamsburg, and from thence crossed Pamunkey River, and Matapony [Mattaponi] River, at Fraser's ferry to Gloucester, remained there, until the surrender of Lord Cornwallis, and was discharged after serving that tour of three months, making six months he served as a soldier in the Revolutionary War. That he was born in Mecklenburg County & State of Virginia in the year 1764, and was living in said County during the Revolutionary War and removed to Halifax after the termination of the war, and do now live in the same. That he has a record of his age that he knew Colonel John Willis & Colonel Alexander – that he believes were regular officers – that he knows of but no person by whom he can prove his services except John Arrington¹ – that he has no documentary evidence to prove his services – that he can find no discharge – that he hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension Roll of the agency of any state.

[Veteran was pensioned at the rate of \$20 per annum commencing March 4th, 1831, for 6 months service as a private in the Virginia militia.]
