Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

North Carolina Richmond County | Court of Pleas & Quarter Sessions

On this the 20th July 1832 Personally appeared before the worshipful Justices of the Court of Pleas & Quarter Sessions of the County of Richmond James Roper a Resident of said County and State aged Seventy years who being first duly Sworn according to Law doth on his oath make the following declaration in order to obtain the benefit of the Provision made by the Act of Congress passed June 7, 1832 –

That he enlisted in the Army of the United States in May 1777 and Served in the Second Battalion [sic, Regiment] of the North Carolina Line under officers whose names & Ranks he thinks were as follows, viz., Craddock Captain [sic, then Lt./Captain John Craddock], H Muifree [sic, Hardy Murfree] Major, and Patton [sic, John Patten] Col. – that he resided in the County of North Hampton [Northampton] North Carolina at the time he entered the Service that he marched to Alexandria and after some delay at that place occasioned by the Small Pox he proceeded to or near Valley Forge where he Joined General Washington's Army & passed the Winter, that in the Succeeding Spring he marched towards New Jersey and was at the Battle of Monmouth [October 28, 1777] that Sometime afterwards he marched to Charleston S.C. passing through Wilmington N.C. and was discharged Sometime in November 1780 which discharge he now has in his Possession, and he further states that sometime after his Return home he hired as a Substitute for Robert Boykin for three Months during which time he was in the Battle at Guilford N.C. [Guilford Court House, March 15, 1781] where he received a Wound in his Head & Arm; that Soon after the Expiration of said Service he hired again as a Substitute for twelve Months in the place of John Garrin and that during that Service he was in the Battle at the Eutaw Springs SC [September 8, 1781] the Spring following he was discharged, which discharge he has Lost -

He hereby relinquishes every Claim whatever to a Pension or an annuity except the Present & he declares his name is not on the Pension Roll of any Agency in Any State. Sworn to & subscribed the day & year aforesaid

The bearer hereof James Roper a Soldier belonging to the Second North Carolina Continental Battalion has served honestly and faithfully in the above Battalion for the space of three years and is thereby discharged having served the time for which he Inlisted for as appears by Lieutenant Henry Vinson's Certificate, he having rec'd his pay, arrears of pay, clothing of all sorts and all other Just demands from the time of his Inlisting in the said Battalion to this day of his discharge as appears by his receipt on the back of his discharge
