## Southern Campaign American Revolution Pension Statements & Rosters

Pension application of Hartwell Savedge S7452 Transcribed by Will Graves f8VA 1/14/12

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

## Virginia Surry County to wit

On this 24th day of September 1832 personally appeared before the Justices of the County Court of the County aforesaid sitting Hartwell Savedge resident in the County aforesaid aged seventy-six years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed June 7th 1832.

That he entered the Service of the United States under the following named officers and served as herein stated in the Virginia Militia that he was stationed at Swans Point on James River in Surry County, he believes, under Captain Jacob Faulcon [?]<sup>1</sup> and Lieutenant Beniman [?]<sup>2</sup> in 1776 and served at least six weeks – that his next tour was in the militia at Cabin Point in the same County in the year 1777 under Lieutenant Warren, when he served the same length of time – that in 1778 he again marched to a place called the Barracks near Williamsburg Virginia under Captain Willis Wilson and Colonel David Mason when he was in service the same length of time. That in 1779 he marched to Babs [Babb's] old field and from that to Suffolk under Captain Willis Wilson & Colonel Blunt [Benjamin Blunt of Southampton County?] and served the same time, That in 1780 he marched to Hutchins' on James River, the same day that the British landed at Cobham and served under Captain Wilson and Lieutenant Moring and was in Service up and down the bank of the river for about the same time – that in 1781 he volunteered and marched up the River under Captain William Hart and was at the battle of Petersburg [April 25, 1781] – and marched [indecipherable word] to Richmond under General Muhlenberg and Colonel Gaskin [probably Colonel Thomas Gaskins], and in the same year he marched to a place called Murders [?]<sup>3</sup> old field near Southquay under Captain Jas. Kee [James Kee] – and he further declares he never received any Compensation for his Services at the time of performing the same nor since and his whole Service is at least ten months and a half. He hereby relinquishes every claim whatsoever to a pension or annuity except the present and declares that his name is not on the pension Roll of the agency of any State, Sworn to and subscribed the day

and year aforesaid that he knows of no one living by whom he can prove all his services aforesaid.

Virginia Surry County to wit

This day Hartwell Savedge personally appeared before me Charles H Graves a Justice of the Peace for said County & made oath that in the year 1780 he served a tour of duty as stated in the foregoing declaration of not less than six weeks and that in the year 1781 he served two tours of duty each of which was not less than six weeks; he also made oath before me that he knows of no person by whom he can prove his services as stated in the annexed declaration.

Given under my hand as a Justice of the Peace in the County and State aforesaid this 23rd day of February 1833

[Veteran was pensioned at the rate of \$32.66 per annum commencing March 4th, 1831, for service as a private for 9 months and 24 days in the Virginia militia.]
