[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina Haywood County: SS

On this 3rd day of October 1833 personally appeared in open Court before the Honorable the Judge of the Superior Court of law and Equity for said County of Haywood being a court of record now Sitting Jacob Shook a resident of said County & State aged Eighty-four years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed 7th June 1832.

That he resided in what is now Lincoln County North Carolina when he entered the service of the United States under the following named officers and Served as herein Stated (to wit) That in the month of March in the year 1775 as he now thinks he entered the service of the United States as a volunteer in the company Commanded by Captain William Bateman [William Beekman] in the Regiment commanded by Colonel Christopher Bateman [Christopher Beekman] in the Brigade commanded by General Rutherford [Griffith Rutherford] and marched to what was then called Cross Creek now Fayetteville North Carolina against the Scotch Tories which tour lasted one month or more the precise time not now recollected as a part of the Tories being taken and the balance dispersed before he reached that place he remained at that place but a short time.

That on the 9th of August 1776 he Served a tour as a drafted militia man against the Cherokee Indians in Captain Rodolph Conrad [Conrad Rudolph] Company in Regiment Commanded by Colonel Christopher Bateman in the expedition Commanded by General Rutherford and served two months.

On the 10th of May 1781 he was drafted for a three months tour against said Indians and marched to Davidson's Station at the head of the Catawba River in what is now Burke County North Carolina under Captain Daniel Smith which time he Served & was discharged by said Captain on the 10th day of August in that year which discharge is herewith transmitted he received no discharge for the two first tours.

He was born in the County of North Hampton [Northampton] in the State of Pennsylvania on the 19th of April in the year 1749 and is now eighty-four years of age he has lived in the County of Burke North Carolina since Revolutionary War & now lives in the County of Haywood in said State he has no record of his age was not attached to any Continental Regiment nor was he acquainted with any regular officer and Has not any proof of his Service either documentary or the testimony of any person whose testimony he can procure that he knows of except that herewith transmitted.

Question first Where were you Born

Answer in north Hampton County in the State of Pennsylvania

2nd Quest have you any record of your age

Ans. I have none

Quest 3rd Where were you living when called into the Service where have you lived since the Revolutionary war and where do you now live

Ans. I was living in what is now Lincoln County State of North Carolina when called into Service have lived since in Burke County in that State and now live in Haywood County Quest 4th How were you called into service were you drafted did you volunteer or were you a Substitute

Ans the first tour I served as a Volunteer the other two I was drafted

Quest 5th State the names of some of the regular officers who were with the troops where you served such Continental & militia regiments as you recollect and the general Circumstances of your Service

Ans I knew none of the regular officers there being none with the troops I served with nor was I with any continental Regiment as I now believe nor have I a distinct recollection of the militia regiments I served with all the time I served was against the Indians except the first tour against the Tories

Quest 6th Did you ever receive a discharge from the Service if so from whom was it given & what has become of it

Ans. I received none of the first two tours the last I received one from Captain Daniel Smith Quest 7th State the names of persons to whom you are known in your present Neighborhood and who can testify to character for veracity and their belief of your Service as a soldier of the revolution

Ans I am acquainted with Jacob Fulbright and Andrew Shook there being no clergyman in my neighborhood with whom I am acquainted who has knowledge of my Revolutionary character

He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any State.

Haywood County, North Carolina, October 3rd, 1833, Jacob Shook, aged 84 years: "That he resided in what is now Lincoln County, NC when he entered the service of the United States under the following named officers...: That in the month of March in the year 1775, as he now thinks, he entered the service as a volunteer in the company commanded by Captain William Bateman [spelled Beekman] in the regiment commanded by Colonel Christopher Bateman [spelled Beekman] in the brigade commanded by General Rutherford, and marched to what was then called Cross Creek [now Fayetteville, NC] against the Scotch Tories, which tour lasted one month or more, the precise time now not recollected. As a part of the Tories being taken and the balance dispersed before he reached that place, he remained at that place but a short time."

"That on the 9th of August, 1776, he served a tour as a drafted militia man against the Cherokee Indians in Captain Rodolf Conrad's company in regiment commanded by Colonel Christopher Bateman in the expedition commanded by General Rutherford, and served 2 months."

"On the 10th of May, 1781, he was drafted for a 3 months tour against said Indians and marched to Davidson's Station at the head of the Catawba River in what is now Burke County, NC under Captain Daniel Smith, which time he served and was discharged by said captain on the 10th day of August in that year, which discharge is herewith transmitted. He received no discharge for the first 2 tours."

"He was born in the county of Northampton, Pennsylvania on the 19th of April, in the year 1749 and is now 84 years of age. He has lived in the county of Burke since the Revolutionary War, and now lives in the County of Haywood in said state. He has no record of his age, was not attached to any continental regiment, nor was he acquainted with any regular officers...I am acquainted with Jacob Fulbright and Andrew Shook", etc.
