Pension application of Jacob Sparrow S7581

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June 0.786." Please call errors or omissions to my attention.]

At a Court held for Accomack County on the 27th day of August 1832 Jacob Sparrow of the County of Accomack this day personally appeared in Court and made the following declaration in order to obtain the benefit of the Act of Congress of the 7th day of June 1832 viz.

"State of Virginia, Accomack County SS. On this 28th day of August 1832 personally appeared before the Justices of the County Court of Accomack County now sitting Jacob Sparrow aged about sixty-eight years and now a resident of Accomack Parish in Accomack County Virginia who being first duly sworn according to law doth on his corporate oath make the following declaration in order to obtain the benefit of the provisions laid by the Act of Congress passed June 7th 1832 – him

That he served in the Militia of Accomack County State of Virginia from the time he was sixteen years of age till he was free from duty by reason of his age – that during the war of the Revolution he served under Captain Jesse Dickerson & Lieutenant Thomas Sandford of the Militia – that during all the Revolutionary war the Militia of this County were constantly called upon to keep guard by turns about a week – that generally about 15 or 20 of each Company Guard at a time – that, in consequence of the exposed situation of the County & the constant state of alarm it was necessary to keep a regular guard on the sea side & Bay side of the County to prevent depredations being committed – that he kept guard on Pocomoke River, at Chincoteague & at General Cropper's [perhaps John Cropper's] barracks and that he verily believes he was in service about two years – that he was born in 1764 & was enrolled 1780 and he considered himself every day liable to be called upon at a moments warning to attend alarms - that he does not know that he was in actual service under arms quite two years, but he was enrolled about three years before the war ended & was in service more than half the time under arms as he believes - this deponent was born in this County & has always lived where he now lives on Mesongoes Creek [Masongo or Mesongo Creek] - that he has a record of his age in a Sermon Book at home showing that he was born in 1764 – that he received no written discharges at the end of his tours. This deponent was well acquainted with Colonel Cropper, Major Poulson [perhaps Major John Poulson], Captain Gilchriss [perhaps George Gilchrist], Colonel Levin Joynes & generally or quite all the officers from this County – The Militia of this County were commanded by Colonels Simpson, Corbin & Cropper during the Revolutionary war. This applicant is well known to Colonel Drummond, Captains Thomas & Henry Fletcher, Captain Samuel Henderson, Doctor E. H. James & almost all the Citizens of the upper Parrish of this County any of whom can testify as to his character for truth & veracity & as to their belief of his services aforesaid. He hereby relinquishes every claim whatever to a pension or annuity except the present & declares that his name is not on the pension roll of the agency of any State."

[Veteran was pensioned at the rate of \$80 per annum commencing March 4th, 1831, for service as a private for 2 years in the Virginia service.
