Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." State of North Carolina, Burke County: Court of Pleas and Quarter Sessions October court 1832

On this 26<sup>th</sup> day of October 1832 personally appeared in open Court before the Justices of Court now in Session Joseph Starns a resident of said County & State aged 76 years who being duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of an act of Congress passed the 7<sup>th</sup> June 1832.

That he entered the Service of the United States under the following named officers and served as well as he can recollect as herein set forth.

1<sup>st</sup> He served under Captain ~~Fowler~~ Aaron <sup>Lewis</sup> Fowler in a three months tour on Clinch River against the Cherokee Indians stationed at a Fort on Clinch called Fowler's Station when the time was out came home, all hands only dismissed by officers no discharge required or given – belonged to the Virginia Militia, Washington County, William Campbell Col. of his Regiment.

2<sup>nd</sup> He served a three months tour under Captain John Jimerson [?] against the Indians at Harrison's Station from the same place and out of the same Regiment the Fort was on the North Fork of Holston River—dismist [dismissed] as before.

3<sup>rd</sup> He was out again on a tour of three months (whether they served the whole time he cannot now recollect) Captain he cannot recollect, but it was in Col. Smith's Regiment out to Boonsboro, got there after the Indians had just attacked the Fort & had a long & severe contest Daniel Boone was the Commander & defeated them. He Joseph Starns drove the pack horses out – came back & was discharged as before – this in the year 1778 he <sup>recollects</sup> this for the horses were branded with the year for some reason perhaps, that we might know them &c. but the former tours he cannot recollect the dates of.

4<sup>th</sup> Fourth was served under Captain Neal in Colonel Wm Campbell's Regiment Term of Service four months or over. Went to King's Mountain & was in that battle [October 7, 1780] Furgerson [sic Patrick Ferguson] of the British Army was killed after the battle was over Campbell left him to take care of the wounded for 2 months Captain Neal did not go into the Battle with them for he had lost his horse & Neil's company was commanded a young man of the name of Shelby not Colonel Shelby – in or about 1780 he was a volunteer in this expedition.

5<sup>th</sup> Tour of regular duty was to the Cherokee nation went over to the Tennessee Valley & Hiwassee Towns under Colonel Arthur Campbell of the Virginia Militia he was a volunteer in this tour of duty for he started from home (having just returned from a Scouting party in which his father & brother in law were killed) & joined Campbell whatever length of time they might be out to seek satisfaction Burnt the Cherokee towns & beat them well. Got home & were not called on regular duty again only as Scouts.

I hereby relinquish every claim whatever to a pension or annuity except the present and declare my name is not on the pension list Roll of the Agency of any State that I have no documentary evidence of my Services nor can I prove them by any person whose testimony I can Procure except

Leonard Hice<sup>1</sup> whose affidavit is hereto annexed marked (A.)

#### Questions by the Court

1<sup>st</sup> When and where were you born?

Answer I am told it was on Smith River in the year 1755. Smith River rises in Virginia & runs into North Carolina I cannot say which side of the line I was born on.

2<sup>nd</sup> Have you any record of your age & where is it, if any

Answer I have none myself, but I recollect it was set down in my father's Bible and I have seen it often.

3<sup>rd</sup> Where were you living in the Revolutionary war & when called into Service, where have you lived since the Revolutionary war & where do you now live

Answer I was living on Holston River in Virginia when called into Service, and Continued to live there, when at home, during the Revolutionary war & until it ended & lived there until about 1784 when I moved to Mecklenburg N. C. & from thence moved to Burke where I now live in 1816 where I have lived ever since.

Question 4<sup>th</sup> How were you called into Service, were you drafted or did you volunteer or Substitute & if a Substitute, for whom

When I lived in Mecklenburg N.C. I went as a Substitute in the place of a man I do not recollect we went against the Scotch Tories to Cross Creek against the Scotch & from that to a place called Cambleton [? Campbelltown] when I went to Fowler's on Clinch I was drafted & when I went to Harrison Station I was a Substitute but for whom I cannot say for I have forgotten his name when I went to Boonsboro in 1778 in Smith's Regiment I was a volunteer, & when I went under Colonel Campbell to King's Mountain I was a mounted volunteer & when I went to the Cherokee nation under Colonel Arthur Campbell I was also a mounted volunteer. After that often out as a volunteer as a Scout vs. Indians & Tories but never again in Regular Service.

Question 5. State the names of some of the regular officers who were with the Troops where you Served, such Continental and militia regiments as you can recollect and the General circumstances of your Service

Answer I was under Colonel Campbell at King's Mountain I think it was in 1780 month of September Colonel Cleveland of N. C. militia commanded the Right wing and Col. Sevier of the N. C. militia from over the mountain now Tennessee commanded the Left wing of the Army. Colonel Campbell of Virginia Troops marched up in front we surprised & took their picket guard without a noise then a man named Philip Grier a messmate of mine stood next to me on the left side shot a man who came off from the British Guard into the wood, this made the enemy's Guard retreat to the main body – we advanced on them before they could form & gave them a fire and before we could load again the British formed & charged on us and we retreated across a little Hollow & loaded & then advanced on them & kept up such a constant fire for 40 or 50 minutes that they never made us retreat again, but we stood still advancing upon them till the end of the battle, I understood that the principal part of the force of the Enemy were Tories. I saw Ferguson of the British Army lying dead twas said he had 7 bullets shot through him. When we were living on Clinch I was almost always on the Scout when not in regular Service. I was once in a company of four in the year 1779 April 7<sup>th</sup> over on a water course in Virginia back of the Settlements towards Boonsboro where we were fired on by about 25 or 30 Indians and my father, my uncle Frederick Starns and brother in law – Michael Moyer were shot and I made my escape although they ran me upwards of a mile & kept firing on me but I made my escape in the Cain [sic, cane] and other undergrowth we went back to Boonsboro & he sent him along with others to receive some prisoners & take them on to a place called the Town House on Holston River.

Question 6 Did you ever receive a discharge from the service & if so by whom was it given


Answer I never received a written discharge for I lived within 3 miles of Col. William Campbell & when my services was not longer required he would tell me to go home until called or from the expiration of the year 1778 up to the close of the war I stood as a minute man and served very often whenever the Indians or Tories troubled us I kept a good horse and thought myself bound to protect the frontier & we did so although many lives were lost.

Question 7<sup>th</sup> State the names of Persons to whom you are known in your Neighborhood, who and who can testify as to your character for veracity; and good behavior or your Services of the revolution.

Answer I have but few of my neighbors here but Abner Payne Esq. who has made certificate marked (A) has said that he believes it and Leonard Hice who also made affidavit on same paper marked (A) at the foot has sworn that I served with him also John Boone Esquire High Sheriff of the County of Burke.

State of North Carolina Burke County: Personally appeared before me the undersigned a Justice of the Peace for the said County Joseph Starns who being duly sworn according to law deposeth and saith that by reason of Bodily infirmity & old age, and the consequent loss of memory, he cannot swear positively as to the precise length of his service & the other circumstances thereof but according to the best of his recollection he served not less than the periods mentioned below and in the following grades

He served a three month tour at the commencement of the revolution just after the Declaration of Independence against the Cherokees at Fowlers Station under Captain Aron Lewis as a private soldier, he thinks in the year 1777 he served another Tour of three months in the same year as a private under Captain John Jimerson at Harrison's Station all in the County of Washington, the third tour of duty was under Colonel Smith in his Regiment he was under a Captain Crabtree as he thinks, his name was he now recollects that he was out fully three months for they started about the last of August or 1st of September in 1778 & he served out his time & got home just before Christmas. Fourth tour of service was for four months under Captain Neal of Colonel William Campbell's <sup>(was a horseman)</sup> went to & was in the battle of Kings Mountain – he thinks in 1780, discharged & got home just about Christmas. The next tour of duty was undertaken for three months under Colonel Arthur Campbell of the militia to the Cherokee nation, burned their towns as before stated, not out the whole 3 months but knows better than 2, this in the year winter of the year 1781 & 1782 for we ate our Christmas dinner in the Indian town on the Tennessee [River] & then went over to Valley & Highwassay [Hiwassee] Towns. – In all that he is entitled to be paid for as in the subjoined Statements shown

State of North Carolina Burke County: This day came Leonard Hice before me the undersigned Justice of the Peace for the said County and made out that he knew Joseph Starns did serve several towers [tours] against the Indians and Tories and that he knew also that he was in the battle at Kings Mountain under the command of Colonel William Campbell and helped him off of the battle ground after himself was wounded – and that it was in 1780 – Sworn to and subscribed the day and date above written.  
[October 6, 1832] S/ Leonard Hice, X his mark

[f p. 18: Abner Payne made affidavit that Joseph Starns is entitled to "explicit confidence" in his statement made on oath and that he enjoys a reputation in this part of the Country as having been a soldier of the revolution.]

[Veteran was pensioned at the rate of \$46.66 per annum commencing March 4th, 1831, for service as a private for 14 months in the Virginia militia.]
