## Pension application of Melcher Tar (Tarr, Dorr) S7674 Transcribed by Will Graves

Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## State of North Carolina, Davidson County

On this 14 day of August 1832 personally appeared in open Court before the Justices of the Court of Pleas and quarter Sessions, now sitting, Melcher Tar a resident of Davidson County and State of North Carolina aged 80 years who being first duly Sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7<sup>th</sup> 1832.

That he entered the Service of the United States under the following named officers and served as herein stated General Ash [sic, John Ashe], Colonel Lytle [sic, Archibald Lytle], and Captain Cowan [David Cowan] are the only officers whom he now recollects to have served under. The claimant entered the Service in the year 1779 and left in 1780 He resided in the County of Rowan and State of North Carolina when he entered the Service a drafted Militia Man He was engaged in the battle fought at Briar Creek [Brier Creek, March 3, 1779] in the State of Georgia and at Stono River [June 20, 1779] in the State of South Carolina He was served nearly wounded in the battle at Stono River and was soon after this discharged. He marched through the States of North Carolina, South Carolina and Georgia and that he has no documentary evidence to prove the facts as above Stated.

He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any State.

I George Fritts of the County of Davidson & State of North Carolina do hereby Certify that Meltzer Tar Served in the Revolution as he States in his declaration. I was well acquainted with Mr. Tar before the War of the Revolution. I lived in the neighborhood of Mr. Tar and well recollect when he entered the

service. I soon after entered the Service myself. I was in the same Regiment that he was in and frequently saw him while in the Army. I saw him in the battle at Briar Creek where he displayed the most ardent Courage.

Ans. I was living in Rowan County N. C. when called into the Service and I am now living in the County of Davidson N. C.

4<sup>th</sup> How were you called into service; were you drafted; did you volunteer, or were you a substitute and if so for whom did you substitute?

Ans. I was drafted.

Ans. I did receive a discharge from the service. It was given by Colonel Lytle which is now lost. [Omitted 7<sup>th</sup> State the names of persons to whom you are known in your present neighborhood, and who can testify to your character for veracity and good behavior and your services as a Soldier of the Revolution.]

On this the 4<sup>th</sup> day of February 1833 personally appeared before me the undersigned a Justice of the peace of the County of Davidson & State of North Carolina Melcher Tar who being duly sworn deposeth & saith that he entered the service of the United States in the year 1779 as a Militia Man in the grade of a common Soldier. He left the service in 1780 & served 12 months.

He further deposeth & saith that there is no clergyman residing in his neighborhood who can testify that he served in the Revolutionary war.
