Pension application of Calvin Williamson S7949 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of SC, Laurens District

On the 26 day of March one thousand eight hundred & thirty three personally appeared in open court before Judge Evans one of the judges of the court of common pleas now sitting Calvin Williamson, a resident of South Carolina Laurens District aged 75 years, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of congress passed June 7th 1832. That he entered the service of the United States under the following named officers & served as herein stated. That he volunteered in the year 1778 in Laurens District South Carolina under Capt. John Stephens. The other officers belonging to the Regiment were Captains Wm Mulwee [sic, William Milwee]¹, Ritchie² & Rainey [probably Benjamin Rainey], Major Jonathan Downs, ³ Col. McCreary & Col. James Williams, General Andrew Williamson, and [he] performed service on the Cherokee Line for the term of three months, the time for which he volunteered & was discharged by Capt. John Stephens. That he volunteered in the latter part of the year 1781 in Laurens District South Carolina under Capt. James Dillard in the Little River Regiment of South Carolina militia. The other officers of the Regiment were Captains Laird [Robert Laird], 4 Lewis Saxon, 5 Samuel Wharton, Major Smith, Col. Levi Casey⁶—General Andrew Pickens and [he] performed service by marching through Laurens, Union and Spartanburg Districts & the upper part of So. Carolina for six months, the time for which he volunteered, and was discharged by Capt. James Dillard in Laurens District. That he has no documentary evidence of his services—that Capt. James Dillard & Thomas Williamson can testify to my services—that he was born in North Carolina in the year 1759 & removed to South Carolina Laurens District in the year 1771—that he has no record of his age—that he was living in Laurens District South Carolina when he entered service—that he was a volunteer both terms of service—that the officers he was under are as hereinabove stated—that he received no written discharge from his first term of service—that he had a written discharge from Capt. James Dillard but has lost it long since—that the Revd. David Simmons, Thomas Williamson & James Dillard can testify as to is character for veracity—and that James Dillard—Thomas Williamson can testify to his revolutionary services—that he hereby

relinquishes every claim whatever to a pension or annuity except the present & declares that his name is not on the pension roll of any agency in any state.

Calvin Williamson being personally before me and being duly sworn on oath saith the nature of his first tour was against the Indians under Captain John Stephens he was a volunteer and belonged to the Militia they had a Station on the Indian Line the above named Capt. J. Stephens was under Colonel James Williams and the said tour was performed in the date 1778 and he was on service three months and ten days the above service was rendered in the above State and partly in the above District and partly in the adjoining Districts.

And the nature of his second tour was under Capt. Dillard as a ranger under the orders of Genl. Greene part of said Capt. Dillard's company was sent on the Genl. Greene and part stayed back to range through four Districts unless called out of the above by orders of the above Genl. Greene, but was not called out of the above State that he served fully six months or more the latter part of the date of 1781 and the fore part of 1782 and this deponent sayeth that he was three months and ten days a militia man in service and six months a regular soldier of the United States Army.

Personally appeared James Dillard Senior⁷ Esq. (being an old and Infirm person and as such unable to attend in Court) before me Robert Long Esquire one of the Justices of the Quorum of the district aforesaid, and being duly sworn on his oath saith that Calvin Williamson volunteered in the Service of Liberty in the Revolutionary War under him (this deponent) then a Captain in the Little River Regiment of South Carolina Militia. In the latter part of the year one thousand seven hundred and eighty one & beginning of the year 1782 that to the best of his (this deponent's) recollection he says he must have served fully Six months at least; that he continued in the Service until he was discharged and further this deponent saith not.
