Pension application of John Wilfong (Willfong) S7951 Transcribed by Will Graves f24SC&25NC¹ rev'd 5/28/10 rev'd 10/30/13

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina Lincoln County: Be it known that John Willfong [sic] personally appeared before me Michael Cline one of the Justices of the peace for said County of Lincoln who on his oath declares, that he is the same Identical John Willfong who served as a private in the Company commanded by Captain John Sigmon in the Regiment commanded by Colonel McDowell of the County of Burke in said State aforesaid in the Militia in the Revolutionary War and that he was wounded in the left arm while in service at the Battle of King's Mountain, and that in consequence of said William was placed on the pension List of North Carolina and since transferred to the pension List of the United States at the rate of \$2 per month and further states on his oath that he never received a Certificate for the said pension from the State of North Carolina or from the United States but states that he for some time since he drew his pension from the proper authority of the State of North Carolina and the United States for the North Carolina agency at Fayetteville and that he is the same person that was examined by James Beuny [?] and William Johnston practicing physicians on the 22nd day of October 1822 and that he now lives in the County of Lincoln aforesaid where he has resided for many years and that he is same person he represents himself to be. Sworn to and Subscribed before me this 9th day of November 1822.

State of North Carolina, Lincoln County

On this 30th day of October 1832 personally appeared in open court before the Justices of the County Court now sitting, John Wilfong, a resident of the County of Lincoln and State of North Carolina aged 70 years of age who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7, 1832.

That he entered the service of the United States under the following named officers and served as herein stated: the last of August or the first of September 1780, he entered the service as a volunteer under Colonel Charles McDowell, Captain Sigman, Lt.

Van Horn; marched to Morganton North Carolina; from thence to Cain Creek [sic, Cane Creek] in Burke County North Carolina where they had a slight skirmish; from thence to Watauga; they then returned [on] the same route; joined by Colonels Sevier [John Sevier], Shelby [Isaac Shelby] and Campbell [William Campbell]; to Cane Creek, Burke County North Carolina; from thence to Gilbert town in Rutherford County North Carolina; from thence to the Cowpens where they were joined by Colonels Cleveland [Benjamin Cleveland] and Williams [James Williams] and some Lincoln troops; from thence they marched across Broad River and fought the battle of King's Mountain the same day. Ferguson [Patrick Ferguson] was killed and the whole Army taken prisoner; in which battle he was wounded in the left arm by a ball in consequence of which he returned home on the 8th October 1780.

Entered the service the second time as a volunteer for 10 months [on the] 15th July 1781 as will appear by certificate marked "A" under Colonel Hammond, Captain Cowan, Lieutenant George Hammond, marched from Lincoln, North Carolina to near Augusta Georgia; marched from thence into South Carolina; joined General Greene's Army; from thence to Eutaw Springs and was in the battle in 1781; from thence marched to White Hall South Carolina. In March 1782 marched to the Cherokee Nation under Captain Jesse Johnson; returned to General Pickens in South Carolina where he served the residue of his term and was discharged as will appear by exhibit marked "B".

I hereby relinquish every claim to a pension or annuity whatever except the present and declare that my name is not on the pension roll or agency of any state only on that of the agency of North Carolina which certificate is hereby annexed.

He has no documentary evidence except what is annexed and Michael Cline's independent statement.

1. Where and in what year were you born?

Answer: I was born in North Carolina April 8, 1762.

2nd: Have you any record of your age and if so where is it?

Answer: I have not, but have seen my age in my further testimony [sic].

3rd: Where were you living when called into service, where were you living in the revolutionary war and where do you live now?

Answer: In Lincoln County North Carolina the name of which County has been several times changed.

4th: How were you called into service & see.

Answer: Volunteered.

5th: State some of the regular troops and officers etc.

Answer General Greene, Colonel Washington, Colonel Lee.

6th: Did you ever receive a discharge and if so by whom?

Answer: General Greene commanded at Eutaw, Colonel Washington, Colonel Lee. Washington was taken prisoner at Eutaw. He discharge is to this declaration exhibited [sic].

7th: State the names of persons to whom you are known in your neighborhood who can testify as to your veracity, good behavior and your service in the revolution.

Answer: Michael Cline and John Fritckey [sic].

Sworn to and subscribed the day and year aforesaid.





[Veteran was inscribed on the rolls of North Carolina at the rate of \$2.66 2/3 per month pursuant to a certificate issued November 29, 1822. Veteran was also pensioned at the rate of \$37.54 commencing March 4th, 1831 for 11 months & 18 days service as a private in the North Carolina militia.]
