Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of North Carolina, Rowan County}

On this 21st day of November in the year of our Lord 1832 personally appeared in open Court before the Justices of said Court now sitting Archibald Woodside a resident of the County and State aforesaid aged about Seventy-Seven years who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7th 1832. That he entered the service of the United States under the following named officers and served as herein stated. The deponent saith that he was born in the County of Mecklenburg & State of North Carolina on the 28th day of April in the year 1756 and was raised in said County until he settled in Rowan County where he now lives. That he entered the Service of the United States a volunteer in the Regiment of Colonel Locke [Francis Locke] under Captain James Jack and served a tour of three months in South Carolina for the most part in Camden (S. C.) in the year 1777 which is proven by Captain William Alexander¹ of Mecklenburg County NC. The deponent further states that in September 1778, he volunteered himself for five months under General Rutherford [Griffith Rutherford] and served the five months in North & South Carolina which is proven by William Caragan [sic, William Carrigan²] of Cabarrus County N. C. He further states that in January 1779 he was pressed into Service at Charleston S. C. for three months went from thence to Purysburg on Sayannah River S. C. and at the end of the three months was discharged and returned home. He further states that in August 1780 he was called into service under General Davidson [William Lee Davidson] & Captain John Dickey and was generally under arms was in the battle at Cowans Ford on the Catawba River [p 8] on the 1st day of February 1781, and continued in the Service until the British crossed the South fork of the Yadkin River which was about the 15th of February 1781, to wit 6 months Making in the whole of his services 19 months to the best of his recollection, he states that he does not recollect whether he ever received any written discharge. If he did they are all lost, he further states that he has no documentary evidence and that he knows of no person (except Captain William Alexander and William Carrigan) whose testimony he can procure who can testify to his Services.

He hereby relinquishes every claim whatsoever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any State.

Carolina for three months went from thence to Purysburg on Savannah River was frequently in his company during his services & has no doubt but he served the terms specified he further Deposeth that having confidence in the veracity of the said Archibald Woodside he believes that he served as he Stated in his Declaration.
