Pension application of John Yeager S7985 Transcribed by Will Graves fn43VA¹ 7/14/11

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

This day John Yeager personally appeared before me J L Lindenburger a magistrate for said County, and made oath, that he is the same person who formerly belonged to a detachment from the 7th Virginia Regiment under the command of General Morgan that he was placed on the Pension roll of the State of Virginia at the rate of \$6.66/100 2/3 per month for wounds received during the revolutionary War, and that he has never received a certificate to that effect.

[facts in file: Veteran died January 3, 1831; in September 1837, a Mrs. Hannah Yager of James City, Madison County, Virginia stated that her late husband, John H. Yager was a solder of the Revolution, and that she at that time referred to one 'Thomas Yager'. The relationship, if any of these people to the veteran is not shown by documents in this file.]

I think one of the pension claims relate to this veteran as there is a receipt from a John Yeager for £15, the sum referred to in Gov. Patrick Henry's certificate dated 1786 above.
