## Pension application of John Waldrop S9520 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention.]

## South Carolina, Greenville District

On this the tenth day of October in the year of our Lord 1832 personally appeared in open Court before the Judge of the Court of Common Pleas and General Sessions, now sitting, John Waldrop a resident of the District of Greenville in the State of South Carolina – aged seventy-nine years who being first duly sworn according to law hath on his oath make [sic, made] the following declaration on oath in order to obtain the benefit of the Act of Congress passed June 7<sup>th</sup> 1832.

That he entered the service of the United States under the following named officers and served as herein stated – he entered the service in the spring of the year in which the battle of Eutaw Springs [September 8, 1781] was fought under Captain Lusk [probably Joseph Lusk of the Washington County Regiment of militia] -- Colonel Thomas [John Thomas, Jr.] and General Sumpter [Thomas Sumter] – Lived in North Carolina when he entered the service, County called Sullivan now a part of Tennessee State - He Volunteered was in the Battles of Stono [June 20, 1779] and Eutaw Springs<sup>1</sup> – the Battle of Stono was fought by Sumter<sup>2</sup> General Greene Commanded at the Battle of Eutaw Springs – He was under Captain Walters [sic, Philemon Waters], Colonel Thomas at Eutaw – does not recollect any Continental regiments – he knew Colonel Washington [William Washington], Colonel Lee [Henry "Light Horse Harry" Lee] & General Greene [Nathanael Greene] – those are all the regular officers he recollects serving with at this time – he marched from North Carolina down to the High Hills of Santee – was through Camden several times in Orangeburg S. C. was stationed some time at Orangeburg under Colonel Henderson [William Henderson] - he was wounded at the battle of Eutaw, arm broken he has no documentary evidence – he knows of no one else except one Abner Thompson<sup>3</sup> who can testify to his service. He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the roll of any agency of any State. He was born in Amelia County Virginia in the year "53" - he has a record of his age at home in an old prayer book – was living in North Carolina when called into service – has lived in Granville Districts South Carolina ever since the revolutionary War and now resides here. He has already stated all the regular officers he knows. He did receive a discharge from Captain Walters but it is lost – Silas Whitten [?] – William Blasingame and Asa Crowder are in his neighborhood and can

[Veteran was pensioned at the rate of \$33.33 per annum commencing March 4<sup>th</sup>, 1831, for service as a private for 10 months in the South Carolina militia.]
