Pension application of Nathaniel Whittington S9527 Transcribed by Will Graves f19SC rev'd 6/12/20

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Declaration in order to obtain the benefit of the Act of Congress passed June 7th 1832 State of South Carolina, Marion District} Court of Common and Pleas Fall Term 1832

On this the tenth day of October AD 1832 personally appeared before the Judge of the Court of Common Pleas for the District & State aforesaid Daniel Whittington a resident of the Same State & District aged Seventy years on the 7th February last – who being first duly sworn according to Law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed June 7th, 1832.-- That he was drafted at or about the beginning of the Revolutionary War & entered the Service of the United States under Captain Tristram Thomas in Marlborough District South Carolina. Colonel Simmons [sic, Maurice Simons was an officer of the highest rank he at present recollects. Under him this Deponent marched from Marlborough to Orangeburg – Black Swamp & to Purysburg about fifteen miles from Savannah Georgia. At one of these last mentioned places he was stationed some time as a guard but was compelled to retreat on the approach of the British from Georgia & fled to Charleston South Carolina where his time expired & he returned home. He was out at this time three months ten days. He was drafted again for a month at a time at different times & served under Captain Morris Murphy [sic, Maurice Murphy]; with whom he went to General Francis Marion's camp in the Swamp of Santee River about Thirty miles from Charleston South Carolina. At one time he was stationed at Watboo [sic, Wadboo] Bridge (as he believes) to prevent the British from passing up the Country. Colonel Tarlton [sic, Banastre Tarleton] was stationed at the same time about three miles from Charleston. Marion sent out a party under Colonel Mayam [sic, Hezekiah Maham] to reconnoiter Tarleton's Camp. This party consisted of about thirty men & they succeeded in getting so near to Tarleton's camp that they killed the Sentinel. Tarleton rushed out upon them & they were compelled to recross Santee River & go on back to Wadboo Bridge. At this place the British Scouts fired on Marion's picket guard & drove them in. Marion's men were placed behind a fence on each side of the road where there was a lane & as the British rushed through, Marion fired on them & killed four or five men & horses. Upon this the British retired. Deponent does not recollect any other engagement or anything else which occurred when he was out at that time worth mentioning. When the time for which he was drafted had expired, deponent returned home & was drafted again under the same Captain (Maurice Murphy) under Colonel Lem Benton [sic, Lemuel Benton]; he marched down to Scott's Lake Fort about forty miles from Santee River, which was in possession of the British about 9 hundred in number. The Americans under General Marion & Colonel Lee [Henry "Light Horse Harry" Lee], in number about sixteen hundred, attacked the Fort & were repulsed with the loss of Thirty or Forty men killed. The Fort was only accessible on one side – This side Marion entrenched & put Colonel Lee's regulars to fire on the Fort, through the Port Holes made in the

mound of earth thrown out of the Ditch. He also made a rolling battery & when the British refused to Surrender, he moved up his Battery to the Fort, & as the British showed their heads outside the Fort, Lee's regulars picked them off. In this manner the Americans succeeded in getting up to the Fort & taking possession of it. After this engagement, deponent returned to Marlborough & soon afterwards was drafted again, marched under the same Captain to Birch's Mill about three miles below Mars Bluff on Pee Dee River, in Marion District where he rejoined General Marion – Marion then moved up the River to Cashaway ferry [sic, Cashua Ferry] & crossed over to Boling Green [sic, Bowling Green?] in Marion District where he proclaimed free Pardon to all the Tories who would lay down their arms. To this proposition many of them acceded & joined the Americans. Deponent was drafted at other times under Captain Hinson, Moses Pearson, Standard. He can't tell whether he ever received a discharge, if he did, he has lost it. He was always under Marion & if he ever received a discharge it was from him. He has no documentary evidence of his Service and knows of Samuel Cox² & William Cox³ of Marlborough District now alive who can testify to his services. He was born in Marlborough District South Carolina the 7th day of February 1762 – his age is recorded in a Family Bible at the House of Betsy McTyer in Marlborough District. He has lived in Marlborough since the Revolution except during the last twenty years which he has spent in Marion where he now lives. He is known to David S. Harllee, Samuel Bigham, Thomas Godbold, Thomas Evans & many other gentlemen of respectability who can testify as to deponent's character for veracity and their belief of his services as stated in his declaration. He hereby relinquishes every claim whatever to any pension except the present & declares that his name is not on the Pension Roll of the Agency of any State.
