Pension application of Richard Wimbrough S9529 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

At a Court held for the County of Accomack on the 28th day of August 1832,

Richard Wimbrough of the County of Accomack this day personally appeared in Court and made the following declaration in order to obtain the benefit of the Act of Congress passed June 7th 1832 viz. "Declaration of Richard Wimbrough – On this the 28th day of August 1832 personally appeared in Open Court before the Court of Accomack County now sitting Richard Wimbrough a resident of the County of Accomack & State of Virginia aged seventy years who being first duly sworn according to law doth on his oath, make the following declaration in order to obtain the benefit of the Act of Congress passed June 7th 1832 – that, he entered the service of the United States under the following named officers and served as follows, that he entered the service of the militia in a Company commanded by Captain Richard Justice attached to the second Regiment Virginia, commanded by Colonel Southy Southy Simpson [sic] and after his death by Colonel George Corbin to the end of the War & kept guard at Assawarmaw Creek [sic, Assawoman Creek] and other different places & on many alarms & marches & was called on [to] guard at a place called the Blockhouse and in the whole on duty I believe upwards of two years at different times during the War of the Revolution, I was borned in the County of Accomack State of Virginia in the year 1762, I have no record of my age but from memory of what my parents told me & the time I got out of my apprenticeship. I was enrolled in Captain Richard Company attached to the second Regiment Virginia Militia sometime in the summer 1778. I am known by John Laus [?], Maddox Fisher, Henry Fletcher, Captain William Nock."

[fn p. 5: On October 28, 1850 in Accomack County Virginia, the court entered a finding that Richard Wimbrough, a revolutionary soldier, died June 25, 1845 and left the following children Mary Wimbrough and Rachel Wimbrough.]

I Robert Chase¹ aged ninety years a Revolutionary Soldier and a pensioner of the United States, do hereby testify that I was well acquainted with Richard Wimbrough. I lived in the same neighborhood with him and knew that he performed military duty in the Revolutionary war. I served with him in keeping guard at the Blockhouse.

He was in the company commanded by Captain Richard Justice, attached to the Regiment commanded by Colonel Southy Simpson – Captain Justice's Company perform duty in my

neighborhood. I know that his Company with all the other militia Companies of the County was frequently called out to guard, marches, alarms &c &c; and I believe that Richard Wimbrough was in service two years, but the exact time I cannot now say from the long lapse of time now testify to.
